### 4. Project/Program Description

The Pediatric Vision Center and its programs is a partnership between the USF Health Eye Institute and Lions Eye Institute that provides vision screenings, comprehensive eye exams, treatments and surgical interventions, dispenses glasses as needed, at no cost to children who are uninsured and/or socioeconomically disadvantaged. Vision disorders that affect early learning have the best outcomes if treated by the age of 8. The PVC will provide this region with early intervention, follow-up care, STEM education, eye anatomy and eye health education and could serve as a model for pediatric health and education for the State of Florida.

On April 10, 2020, Lions Eye Institute for Transplant & Research Inc received a loan of \$1,525,900 to fund payroll, rent, and utilities through the Paycheck Protection Program (PPP). This loan was forgiven in January 2021. On February 1, 2021, the organization received a second loan of \$1,729,233 to fund payroll, rent, and utilities, which was forgiven on August 2021.

### 14. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

Provide vision screenings, eye exams, eyeglasses, referrals to the University of South Florida (USF) for surgical interventions and create age-appropriate STEM curriculum for eye education purposes to underserved children ages 0-17, primarily uninsured, enrolled in VPK, Title 1 schools and/or in living in low-socioeconomic communities. These services are provided at no cost and are designed to improve school performance, prevent blindness, increase access to health care for the uninsured, and assist families.

### b. What activities and services will be provided to meet the intended purpose of these funds?

The Pediatric Vision Center and its programs is the first facility dedicated to pediatric vision care in our region, becoming a hub for ocular health in our region by offering new treatments and serving as a learning destination for students. Children will receive vision screenings, comprehensive eye exams, early intervention through dispensing glasses, and treatments/surgical care. We will also provide public health education for students, caregivers, school nurses, community centers, etc. regarding ocular health and prevention. Screenings, limited exams, glasses and education services are provided by Lions Eye while more comprehensive clinical exams and surgeries are provided by USF.

### c. What direct services will be provided to citizens by the appropriation project?

Vision screening services, eye anatomy 101, hygiene practices, education to prevent avoidable blindness, STEM curriculum at age-appropriate levels, comprehensive eye exams, eyeglasses and surgical intervention if needed.

### d. Who is the target population served by this project? How many individuals are expected to be served?

Economically disadvantaged persons, at-risk youth, preschool, grade school and high school students. If we understand that vision problems result in skill deficiencies, difficulty in reading and learning, and poor academic performances - which, in turn, create feelings of failure, low self-esteem, and lack of interest in academics - then the connection between vision problems and life problems becomes clear. Hillsborough County Public Schools is in the top ten largest school district in the country, serving 218,505 students at 311 schools. According to Plan Hillsborough, 40% of Hillsborough County residents are living below the poverty line. A large portion of our children cannot receive the comprehensive eye care that they need and deserve. This impacts their ability to achieve success academically and has a domino effect after they leave school.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

In its study "Abandoned in the Back Row: New Lessons in Education and Delinquency Prevention," the Coalition for Juvenile Justice reported, "The biggest finding is that school failure is one of the earliest and best predictors for future delinquent and criminal behavior." The expected outcome is that children in the Tampa Bay region are given the best opportunity for success in schools and in life. We will track the children who are screened and who receive comprehensive eye exams, glasses, and treatments through the program, follow-up with school nurses, parents/caregivers to ensure the children receive the follow-up care and early intervention that they need.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

The equipment and all assets would be liquidated and funding returned to its original source.
