The age of eligibility for vaccines will officially be lowered to 40+ on Monday, 3/29 and to 18+ on Monday, 4/5.

## BILL ACTION UPDATE

### **SB 224: Sales Tax Exemption**

Heard in the Senate Finance and Tax Committee on Thursday, SB 224 passed unanimously. Its next stop is the Appropriations Committee. This bill provides exemptions for seniors from sales tax on certain items that encourage independent living, including bed transfer handles, bed rails, grab bars, and shower seats, to improve quality of life and allow our seniors to "age in place".

### **SB 1070: Estates and Trusts**

This bill creates the "Florida Uniform Directed Trust Act" addressing trusts that grant a trust administration power to a person other than a trustee, and create the "Community Property Trust Act" that allows spouses to transfer property into a Florida Community Property Trust. The bill was heard in the Senate Judiciary Committee and passed unanimously. Its next stop is the Senate Community Affairs Committee on Tuesday, March 30.

### **SB 196: Lactation Spaces in Courthouses**

Heard in the Senate Governmental Oversight and Accountability Committee, the bill passed unanimously. SB 196 requires county courthouses to have a designated space for women to breastfeed. An exemption exists if a courthouse administrator determines a major construction overhaul would be required. I am appreciative of the Florida Association of Women Lawyers (FAWL) and the Guardian Ad Litem (GAL) programs for helping push this bill forward. Its next stop is the Senate Appropriations Subcommittee on Criminal and Civil Justice.



## SENATOR BERMAN'S 2021 FILED BILLS



### SB 180

#### Office of Diversity, Equity, and Inclusion

Creates the Office of Diversity, Equity, and Inclusion to advise the Governor on racial and gender inequities, collaborate with state agencies and engage with stakeholders throughout Florida to develop inclusive practices, work with the Attorney General to identify racist and Jim Crow-era laws needing repeal, and conduct implicit bias trainings within Florida's agencies.

### SB 182

#### Risk Protection Orders

Recognizes that the combination of mental illness and firearms can be lethal and expands the petitioner categories to enable a parent, legal guardian, sibling, or spouse of a troubled individual to petition courts for risk protection orders.

### SB 184

#### Purple Alert

Creates the state's first-ever public advisory system for missing intellectually or developmentally disabled adults whose disappearance poses an imminent threat to their safety.

### SB 186

#### Domestic Violence

Requires those who have committed misdemeanor offenses of domestic violence to surrender, upon conviction, all firearms and ammunition in their possession to law enforcement, so as not to be used to further their violence.

### SB 188

#### Solar Energy Systems Located on the Property of Educational Facilities

This bill exempts solar energy systems from the Cost Per Student Station calculation placed on Florida's public schools, removing a significant barrier they face when trying to switch to cost-saving solar.

### SB 194

#### Crimes Evidencing Prejudice

Brings Florida's statutory definition of a disability in line with the Americans with Disabilities Act and defines crimes committed on the basis of gender and gender identity as crimes evidencing prejudice.

### SB 196

#### Lactation Spaces in Courthouses

Requires all courthouses to have a designated space for women to breastfeed.

### SB 200

#### Student Retention

Allows parents of K-8 students to retain their children in their grade level if they feel their child has not academically progressed enough and gives parents the flexibility to make the decision in the best interest of their child and provide a statutory option.

### SB 224

#### Sales Tax Exemption

Exempting seniors from the sales tax on certain items that encourage independent living, including bed transfer handles, bed rails, grab bars, and shower seats, to improve quality of life and allow our seniors to "age in place".

### SB 358

#### Water Safety

Asks parents of children entering any public or private school system to confirm that their child has had swimming lessons when entering the school system, and allows school authorities to identify students who may not know how to swim and will help put these parents in touch with free or low-cost programs to ensure their child has an opportunity to learn, presuming there is a desire.



## SENATOR BERMAN'S 2021 FILED BILLS



### SB 688

#### Waivers of Exemptions of Applicable Assets

protects Florida residents from unintentionally assigning, pledging, or waiving their rights to assets (such as retirement accounts, annuities and other assets) that are protected under Florida law by requiring that any pledge agreement must specifically identify those types of protected assets in order to constitute an intentional assignment, pledge, or waiver.

### SB 720

#### State Renewable Energy Goals

This critical legislation will require that by the year 2040, 100% of Florida's electricity generation be sourced from renewable energy and that we be carbon neutral by 2050. It will create thousands of good-paying, clean energy jobs and position Florida as a nationwide leader in building a clean future.

### SB 832

#### Town of Lake Clarke Shores, Palm Beach County

Annexes a section of unincorporated Palm Beach County known as "Edgewater Park" into the Town of LCS, creating a seamless delivery of municipal services that are currently shared with PCB, including police, road maintenance, and soon, septic-to-sewer conversion.

### SB 940

#### Specialty License Plates/Disease Prevention & Early Detection

Creates a new specialty license plate for "Disease Prevention & Early Detection" with proceeds benefiting Miami-based Women's Breast & Heart Initiative.

### SB 1036

#### Florida Family Caregiver Task Force

Establishes the Florida Family Caregiver Task Force within the Department of Health to study and make findings regarding the necessary supports for family caregivers and youth caregivers who are assisting the aging or adults with disabilities.

### SB 1038

#### Insurance Coverage for Breast Cancer Tests and Procedures

As a five-year breast cancer survivor, I am keenly aware of how important it is to seek important diagnostic testing following a questionable mammogram. This bill will ensure insurance providers don't charge unlimited amounts for these associated tests in an effort for patients to receive early diagnoses and treatment, keys to saving lives.

### SB 1044

#### Victims of Crimes of Sexual Violence and Sexual Exploitation

Provides that a victim of any crime of sexual violence or sexual exploitation has the right to prevent the disclosure of identifying information or records and prohibits a person or entity in possession of such information from disclosing that information or records without obtaining express written consent.

### SB 1050

#### School Bus Safety

Authorizes school districts to install cameras on district school buses to ensure the safety of students

### SB 1070

#### Estates and Trusts

Creates the "Florida Uniform Directed Trust Act" addressing trusts that grant a trust administration power to a person other than a trustee, and creates the "Community Property Trust Act" that allows spouses to transfer property into a Florida Community Property Trust.

### SB 1252

#### Inland and Coastal Flood Control Funding Assessment

Requiring the Office of Economic and Demographic Research to include an assessment and analysis of future expenditures by federal, state, regional, and local governments necessary to improve resilience to inland and coastal flooding associated with sea-level rise, high-tide events, storm surge, flash flood, stormwater runoff, and increased rainfall in its report.

### SB 1718

#### Renewable Energy Sources

Allows a public educational customer to enter into a contract with a third party to install, maintain, or operate a renewable energy source device. This bill facilitates the use of solar energy.

## BILLS TO NOTE

### [SB 50: Taxes and Fees on Remote Sales](#)

This bill instates an online sales tax for purchases. In the status quo, a state sales tax is not usually collected from online purchases, only in brick-and-mortar stores. Currently, it is expected that Floridians who make online purchases from out-of-state retailers will submit the total sales tax they owe to the state at the end of the year. While this is the expectation, it is not often the reality. This bill aims to rectify this inequality by collecting sales tax on out-of-state online retail purchases at the time of purchase. It is the hope of the bill sponsors that the funds from this new tax will replenish the unemployment fund. Senate Bill 50 passed the Senate Floor yesterday and its House companion, HB 15, is in its last committee.

This legislation is long-overdue, and I support it in concept, but unfortunately, because the unemployment trust fund will be balanced on the back of these dollars, I could not vote in favor of the bill. We need to consider other means to balance the unemployment trust fund separate from the online sales tax - ideally without providing more corporate tax breaks.

### [SB 100: Highway Projects](#)

This bill repeals the Multi-use Corridors of Regional Economic Significance (M-CORES) program and instead authorizes the Florida Department of Transportation (FDOT) to upgrade existing highways with improvements, such as adding new tolled or non-tolled limited access sections to manage highway congestion. In 2019, Governor DeSantis signed the M-CORES program into law, which was intended to revitalize rural communities and provide regional connectivity. The legislature instructed FDOT to assemble task forces prior to the construction of these roads to study the three corridors: the Suncoast Connector, the Northern Turnpike Connector, and the Southwest-Central Florida Connector. All three task forces, however, were unable to make a determination about the needs and impacts of each

corridor because there was limited data available. Instead, they called upon FDOT to continue its evaluation of the corridors using certain guidelines and stated a preference for improving already existing highways instead of proceeding with the new roads. SB 100 repeals the original legislation and implements the task forces' recommendations, which I supported. SB 100 passed the Senate floor on March 25 and will soon be heard in the House.

## AMERICAN RESCUE PLAN

- **Direct Payments to Working Families & Expanding Child Tax Credit** - Providing working families an additional direct payment of \$1,400 per person.
- **Expanding the Child Tax Credit** - The bill makes the child tax credit fully refundable for 2021 and increases the annual amount from the current \$2,000 per child to \$3,000 per child.
- **Increase COVID-19 Vaccinations** - Providing over \$20 billion to establish a national COVID-19 vaccination program and improve the administration and distribution of vaccinations.
- **Scaling up COVID-19 Testing, contacting tracing, and mitigation** - \$47.8 billion for testing, contact tracing, and mitigation.
- **Providing the resources needed to allow schools to safely reopen** - \$130 billion available to states and school districts for immediate and long term relief so they can work with public health experts to safely re-open schools and make up for lost time in the classroom.
- **Extending unemployment benefits** - extends the federal supplemental benefit unemployment benefit through September 6, while keeping the benefit at the current \$300 per week.
- **Housing Assistance** - \$22.5 billion for emergency rental and utility assistance to states, territories, counties, and cities to help stabilize renters during the pandemic
- **Food Security** - Extends SNAP maximum benefits by 15% (through September 30, 2021)
- **Ensuring Affordable Child Care** - \$39 billion through the Child Care and Development Block Grant for child care providers
- **Supporting Small Businesses and Non Profits** - Creates a \$28.66 billion Restaurant Revitalization Fund.
- **State and Local Funding** - \$350 billion for states, localities, the U.S. territories, and the Tribal Governments, including to help keep critical workers on the job.

### Estimates for State and Local Funding

Please note these are only estimates and final amounts may differ

- State of Florida - \$10.2 billion
- Palm Beach County - \$290 million
- Palm Beach County School District - \$400 million

## CARES Food Cards

As a reminder, Palm Beach County residents who qualified for pre-paid debit cards through the CARES ACT funding for food purchases must activate their cards by March 31, 2021.

Cards not activated by March 31, 2021 will expire, and the funds will be swept and redirected to fund other identified needs caused by the COVID-19 pandemic. Cardholders are encouraged to activate their pre-paid debit cards for food assistance prior to the expiration date.
