Workshop sessions and engagements pertaining to economic self-sufficiency, life skills, character, childhood obesity prevention, cultural awareness and the importance of human and community services in addition to scholarships and awards.

c. What direct services will be provided to citizens by the appropriation project?

Beneficial workshops, childhood obesity prevention and interactive activities, and mentoring support for youth in addition to scholarships and awards.

d. Who is the target population served by this project? How many individuals are expected to be served?

Target population is economically disadvantaged and at-risk high school students. Between 100 and 150 high school students are expected to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Improved Physical Health through childhood obesity prevention and healthy lifestyles workshops and engagement in physical movement and exercise at each program session. Improved Mental Health through a life skills workshop session. Enriched Cultural Experience through cultural workshop sessions, tours and involvement. Improve Quality of Education through high quality leadership and life skills development, cultural and character development workshop sessions. Enhanced economic self sufficiency through exposure to economic self-sufficiency, life skills and independent living workshop sessions. Criminal/Juvenile Justice System Diversion through a legal rights and responsibilities curriculum session, community mentors coaching and encouragement. Benefits and outcomes will be measured by Attendance rosters, Participant Evaluative Surveys, Parental Evaluative Surveys, and Program Evaluation.
