The formation and implementation of statewide standards, training and technical assistance to the child welfare system of care to promote and support the inclusion and compensation practices for parents and individuals with lived expertise at all levels from policy to practice. To hire a project director, consultants and parent leaders to design training, and lead in the development, growth, and inclusion of parent voice, expertise and leadership as standard practice. To establish a replicable toolkit, virtual web-based resource center and convene family leadership/system professional venues. To provide seed funding to pilot demonstration study sites to implement the new standards and practices across local systems of care.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The formation and application of best practice standards and guidance.

Conduct a pilot demonstration site study conducted.

Design a replicable toolkit and training. Create and launch a Parent Leadership virtual resource center.

Convene a Lived Expertise/System Professional Symposium.

To coordinate and unify the work being done by various child welfare related parent initiatives emerging across the state of Florida.

#### c. What direct services will be provided to citizens by the appropriation project?

A recruited council of experts, partners, and individuals with lived expertise within child-welfare that will establish a set of standards, training, and access to resources to define, foster and strengthen the relationship between system professionals, policy makers and individuals with lived experience.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is system professionals, community leaders and individuals with lived experience in the child welfare system. This project is expected to serve and impact 500 individuals in year 1.

The outcomes of this project include:

1. Better outcomes for individuals served in the child welfare system as a result of the cultural shift and normalization of parent voice being valued and included at all lelves of the system.
More efficient and effective case planning and services.
Reduced entry into care and shorter length of involvement resulting from authentic engagement, support and

partnerships.

4. ROI through individuals formerly served by the system lending their experience and expertise to improve the system and to provide support to parents as peers.
