### 4. Project/Program Description

Our district embraces parental choice in their children's education. Our Montessori program at Swimming Pen Creek Elementary is one of the most popular magnet options. The demand for this program far outpaces the available seats. The initial costs associated with establishing a Montessori program are high. A Montessori classroom is required to be furnished and have curriculum materials that follow certain guidelines. Preparing and supporting teachers for Montessori instruction is a costly three year commitment that involves a good bit of after hours work and travel.

Funds would be used to expand the program to a Title I elementary school on the opposite side of the school district providing an elite program for the underserved. Due to an established and aging community, the intended school is frequently under 80% enrollment which opens them up for Controlled Open Enrollment throughout the year. This Choice program could serve to boost and stabilize enrollment.

#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

Clay County District Schools embraces parental choice in their children's education. Funds would be used to expand the Montessori program, a magnet option whose interest far outpaces the available seats. The school district would place this second Montessori site at a Title I school across town, providing underserved students with access to an elite educational program. It would also provide enrollment stability for a school with a mobile, transient student population.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Funds would be used to establish a Montessori program at a Title I school in Clay. This would require Montessoriapproved curriculum, furnishings and training for teachers and administrators to ensure the program's success.

#### c. What direct services will be provided to citizens by the appropriation project?

Research shows that students with a Montessori education experience long-term benefits, including leadership skills, self-initiated learning, independent thinking, and self-determination. These students also exhibit stronger than average problem-solving skills, which support their growth as citizens. https://amshq.org/About-AMS/Press-kit/Montessori-Research

#### d. Who is the target population served by this project? How many individuals are expected to be served?

All of our Clay County students would have the opportunity to apply to this program. The students at the Title I school would have priority. At the end of its rollout, this program would serve approximately 300 students ages 3-12.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

# be measured?

The program would provide enrollment stability in a community with a highly mobile student population. Additionally, the Montessori program is expected to increase student attendance, decrease disciplinary incidents and improve students' overall executive functioning skills. All of the qualities contribute to the making of citizens who will positively impact their community. We can measure this using attendance data, disciplinary data, and student observation.
