Bradford County Fire Rescue (BCFR) has a goal to replace an aging fire engine. All front-line apparatus were handed down from the previous volunteer fire departments. The front-line fleet has been plagued with costly repairs and extended down time. Over the past year, BCFR crews have spent the majority of their time in our spare apparatus fleet, which includes one engine from 1998, and two engines from 2000. Safety and reliability have vastly improved over the past 23 years. Our goal is to increase the safety of our first responders, as well as the general public.

#### 14. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The purpose of these funds will be to purchase a new fire engine, which will allow for safer, more reliable delivery of emergency services.

b. What activities and services will be provided to meet the intended purpose of these funds?



This engine will function as a front-line advanced life support unit. This apparatus will provide a reliable means of transportation to deliver high-quality, life-saving interventions.

#### c. What direct services will be provided to citizens by the appropriation project?

The new fire engine will be immediately placed into service as a front-line response unit. This apparatus will be capable of delivering 1000 gallons of water and is equipped with a 1500 gallon per minute pump. The engine will also carry extrication equipment, such as the "jaws of life". A new engine will ensure reliable delivery of these life-saving tools to vehicle crash scenes when needed. Additionally, this unit will be "Advanced Life Support" permitted, meaning it will carry a cardiac monitor, and medications necessary to assist with a medical emergency.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

Bradford County residents and visitors. Approximately 30,000 individuals.

### e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

#### be measured?

A new fire engine will allow for decreased time spent in outdated spare apparatus, which are becoming unsafe and obsolete. Additionally, this should minimize the likelihood of breakdowns while en route to 911 calls, which has occurred multiple times over the past two years. The outcome will be measured by response times, as well as repair costs associated with the new apparatus.
