The County Line Road Bridge is Martin County's only bridge designated as structurally deficient according to the Florida Department of Transportation. Martin County recognizes the importance of providing the safest structures possible. The existing bridge is structurally deficient and functionally obsolete. A new bridge, roadway design, and bike lane will: allow for safer navigation of vehicular and pedestrian traffic; provide a higher load rating and increased commercial access; incorporate innovative corrosion-inhibiting construction materials for increased life span; will be raised in elevation improving resiliency to rising sea levels; and will increase mobility, economic competitiveness, and quality of life in the region.

MC received \$31,272,363 from the American Rescue Plan Act (ARPA) which is currently being utilized to provide grants to community partners and fund capital infrastructure for clean water.

Changes in roadway geometry and alignment will allow for safer navigation of vehicular and pedestrian traffic; a higher load rating and increased commercial access; corrosion-inhibiting construction materials for increased life span; raised in elevation improving resiliency to rising sea levels; increased mobility, economic competitiveness, and quality of life in the region.

c. What direct services will be provided to citizens by the appropriation project?

Safer navigation of vehicular and pedestrian traffic; increased mobility, economic competitiveness, and quality of life in the region.

d. Who is the target population served by this project? How many individuals are expected to be served?

Martin County and Palm Beach County residents.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The new traffic path and roadway design will reduce accident risk for vehicular, pedestrian, and bicycle traffic; safe bicycle and walking paths will increase accessibility, connectivity, and mobility. Improved safety and navigability of the waterway crossed by personal watercraft. The waterway is a tributary of the Loxahatchee River, one of Florida's two rivers in National Wild and Scenic Rivers System. Reduce the time for safe emergency service access to the area west of the Loxahatchee River in southern Martin County. The alternate route for emergency service to the areas west of the waterway is 6 miles or approximately 15 minutes. Monitoring traffic accident counts. Monitoring traffic count for pedestrians, bicyclists, and personal waterway vessels.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

If the project is not completed, funds to be reverted back to FDOT.
