This request will assist in the successful transformation of Phipps Ocean Park to a fully accessible, family-friendly, oceanfront park. The Preservation Foundation of Palm Beach, Inc. in partnership with the Town of Palm Beach, commissioned landscape architect Raymond Jungles to create a masterplan for the existing space that integrates the cultural and botanical properties of the park. The twenty-acre park will showcase the beauty of Florida's native plants, create an environmentally sustainable landscape, and restore habitats for wildlife, while creating an accessible space for all visitors to immerse themselves in the beauty and awe of nature.

The funds will create new permeable, shaded parking lots with associated rain gardens, new ADA accessible walkways throughout the park, and associated site work and grading needed to install these features. With this scope of work, the park will be fully accessible for the first time, and will provide an incredible amenity for all visitors to the park.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

The funding requested covers the anticipated cost to install the features needed to create accessibility throughout the park. The new parking lots will be constructed of concrete and decomposed granite, and will be gracious with ample landscape plantings and shade trees. Incorporated into the parking areas, the rain gardens will redirect, capture, and filter water, so as to avoid unhealthy surface water runoff and improve water quality. The new accessible pathways will allow all visitors to move freely throughout the park, and experience the beauty of nature. The site work and grading proposed are necessary to alter the steep slope of the western side of the 20+ foot tall dune, in order to allow for a more gentle, gradual slope for the walkways.

#### c. What direct services will be provided to citizens by the appropriation project?

The funds will create new permeable, shaded parking lots with associated rain gardens, new ADA accessible walkways throughout the park, and associated site work to install these features.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

It is anticipated that thousands of local residents will visit the park yearly to enjoy the pathways and the beauty of nature, and to go to the beach. Additionally, there are thousands of children who visit the park every year for field trips to the Little Red Schoolhouse (built in 1886 and relocated to the park) and enjoy the park after their field trip, and it is anticipated that this number of student visitors will be maintained or even increased.

# e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

There are many varied benefits expected to be achieved through this project, which will be measured by parking counts: - The project will improve physical and mental health by creating new pathways for passive recreation, surrounded by native plants and the beauty and awe of the natural environment.

The project will create an enriching cultural experience because the park is currently home to the 1886 Little Red Schoolhouse; believed to be the oldest schoolhouse built for that purpose in the state of Florida. The new parking and pathways will directly link to the schoolhouse, providing increased access to this important cultural and historical asset.
The project will preserve the environment as it is predicated around restoring the native ecosystems that would have originally existed on the historic barrier island. The parking lots and pathways provide access throughout the park to restored native plantings, improved habitats for wildlife, and educational information.

#### for failing to meet deliverables or performance measures provided for the contract?

This project has been in planning and development for over two years, and is on schedule to break ground on July 1, 2023. As such, we do not anticipate failing to meet any deliverables in the contract. We would defer to the contracting agency for any appropriate penalties.
