a. What specific purpose or goal will be achieved by the funds requested?



Located in one of the fastest growing communities in the US, Valencia's Lake Nona Campus is at the center of explosive growth and increasing rates of postsecondary participation. Currently serving more than 7,500 students annually, the addition of a second building would allow the College to serve an additional 5,000 students per year in programs including Nursing, Health Care, and Biotechnology, addressing critical workforce needs in the greater Orlando region.

b. What activities and services will be provided to meet the intended purpose of these funds?

This building will allow Valencia College to expand educational offerings in the Lake Nona community to include programs aligned with state workforce initiatives that lead to high-skill, high-wage careers. In addition to the current portfolio of programs offered at the campus including general education and biotechnology, programs in nursing and other healthcare fields will be added.

c. What direct services will be provided to citizens by the appropriation project?

In addition to existing educational programs at the Lake Nona Campus, Building 2 will provide dramatically expanded access to nursing and healthcare program offerings, helping to address the nursing shortage in the state. This expansion will allow residents to pursue high-quality educational opportunities in their local community and provide an expanded workforce for regional employers.

d. Who is the target population served by this project? How many individuals are expected to be served?

The primary target populations of this project are: jobless, economically disadvantaged persons, high school students and university/college students. This building is planned to serve an additional 5,000 students annually.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Valencia maintains a strong commitment to ensure access to affordable educational opportunities while maintaining exceptionally high levels of student success. Building 2 at Lake Nona will provide expanded access to high-quality educational experiences that lead to high-skill, high-wage careers. This outcome will be assessed by measuring enrollment, retention, and completion of students at the Lake Nona Campus.
