Port LaBelle is one of the fastest growing areas in Hendry County with 257 homes being built in 2021, 281 homes built in 2022, and 682 homes having active permits and applications for 2023. This request is to construct a wastewater collection system and wastewater forcemain pumping system to serve approximately 370 customers within Unit 1 of the Port LaBelle Utility System. This area is included in the FDEP Basin Management Action Plan (BMAP) area in the Eastern Caloosahatchee River Basin which requires Hendry County to implement projects that decrease the nutrient load in our local water basins which flow into the Caloosahatchee River with septic to sewer conversions for existing septic tanks and connection for future users.

An agreement with the Florida Department of Health requires that at 30% build out, Units must be taken off septic and placed on central sewer. Unit 1 is located in the NW section of Port LaBelle, just south of State Road 80 and is expected to be one of the fastest growing units due in part to its proximity to schools and is expected to reach 30% build out by 2027. This area is included in the FDEP Basin Management Action Plan (BMAP) area in the Eastern Caloosahatchee River Basin which requires Hendry County to implement projects that decrease the nutrient load in our local water basins which flow into the Caloosahatchee River with septic to sewer conversions for existing septic tanks and connection for future users.

b. What activities and services will be provided to meet the intended purpose of these funds?

Construction services to expand the wastewater collection system into Port LaBelle Unit No. 1.

c. What direct services will be provided to citizens by the appropriation project?

Project does not provide any direct services to citizens

There are a total of 370 residential lots within Unit 1 of the Port LaBelle Utility System Service Area. All 370 lots are anticipated to be connected to central sewer.

This area is included in the FDEP Basin Management Action Plan (BMAP) area in the Eastern Caloosahatchee River Basin which requires Hendry County to implement projects that decrease the nutrient load in our local water basins which flow into the Caloosahatchee River with septic to sewer conversions for existing septic tanks and connection for future users. This project would provide both economic and environmental improvements for Hendry County. The methodology used to measure the outcome will be the number of lots that can be serviced by central sewer.
