Dear Senator Richter and Members of the Florida Ethics and Elections Committee:

By way of introduction, I serve as general counsel to the Florida Virtual School; am a past member of the Florida Commission on Ethics and current Chairman of the Greater Orlando

Aviation Authority. However, I am writing this letter to you in my role as general counsel to

Florida Virtual School upon request of the Chairman of the Florida Virtual School Board of

Trustees and the President of the school.

This morning, Florida Virtual School received a copy of an e-mail sent to the Senate Ethics and Education Committee from a Ms. Kelsey George regarding Michael Olenick, a candidate for confirmation for the State Board of Education. After receipt of the email, it was decided by the Chairman of the Florida Virtual School Board of Trustees and the President that I should send this letter correcting the libelous and malicious inaccuracies contained in Ms. George's letter.



First, Ms. George is a 25-year-old individual who is a former employee of the Florida Virtual School. Ms. George's mother, a former employee of Florida Virtual School, was non-renewed by the President this past June, 2014. Ms. George herself, resigned her employment with FLVS the past Spring, 2014.

Second, Ms. George has never been approved by the Florida Virtual School Board of Trustees to serve as a member of the Board of Directors of the Foundation for Florida Virtual School. Ms. George also misrepresents the role of the Foundation as that role is defined by the Florida legislature in Florida Statute 1002.37. It was this kind of confusion and other concerns raised to various Board members of the Florida Virtual School Board of Trustees, that led Mr. Olenick in his fiduciary role to request an audit of the Foundation. Thereafter, based upon some of the issues raised in the audit and other information requested, Mr. Olenick requested certain information from the Foundation which were public records. The Foundation never provided all of the information requested. Mr. Olenick advised that he would not meet until all of the public records were produced and examined by the FLVS Finance Director. To date the

records have not been produced in total and FLVS has gone to court to obtain among other relief an order from the court directing the Foundation staff to turn over public records.

Third, contrary to Ms. George's representation that "he [Mr. Olenick] abruptly resigned from the FLVS Board of Trustees following many questionable unethical actions that occurred under his leadership while on this Board" nothing could be further from the truth. Mr. Olenick only resigned from the Florida Virtual School Board upon the governor's requesting he serve as a member of the State Board of Education. Mr. Olenick was unanimously elected chairman of the Florida Virtual School Board by his colleagues on the Board and his leadership was overwhelmingly supported by his colleagues and the leadership of the administration that Mr. Olenick and the Board helped bring to FLVS. It should be noted that Mr. Olenick led the Board and the new administration to improved efficiencies in the delivery of Florida Virtual School services. It now appears Ms. George seeks to malign Mr. Olenick because of his commitment to leading the Board's goal of improving Florida Virtual School.

Finally, I trust this letter provides insight into the motives and incorrect information provided by Ms. George to your committee. The Chairman of the Florida Virtual School Board of

COMMITTEE SUBSTITUTE - Substantial Changes

I. Summary:

CS/SB 1360 defines "address of legal residence." The bill requires voter registration applications to contain the applicant's address of legal residence, including an apartment, suite, lot, room, dormitory room number, or other appropriate identifier. The bill states that failure to provide a distinguishing apartment, suite, lot, room, or dormitory room or other identifier on a voter registration application does not impact a voter's eligibility to register to vote or to cast a ballot. The bill also provides that failure to provide a distinguishing apartment, suite, lot, room, or dormitory room or other identifier on a voter registration application may not serve as the basis for a challenge to a voter's eligibility or reason to not count a ballot.

Under the bill, Supervisors of Elections are required to include within their list of valid residential street addresses all information necessary to distinguish residences including a distinguishing apartment, suite, lot, room, dormitory room, or other identifier.

The bill is effective July 1, 2015.

II. Present Situation:

The Florida Voter Registration Act (FVRA)¹ delineates the qualifications and requirements necessary for a person to register to vote in Florida.² In order to be a registered voter in Florida, a person must be at least 18 years of age, a citizen of the United States, a legal resident of Florida, a legal resident of the county in which the person seeks to be registered, and register pursuant to the Florida Election Code.³

The Department of State must prescribe by rule a uniform statewide voter registration application.⁴ The uniform statewide voter registration application must be designed to elicit certain information from the applicant.⁵ A voter registration application is considered complete if it contains the following information necessary to establish the applicant's eligibility:⁶

- The applicant's name, legal residence address, ⁷ and date of birth.
- A mark in the checkbox affirming the applicant is a citizen of the United States.
- The applicant's current and valid Florida driver license number or identification number, or if
 the applicant does not have a Florida driver's license or identification card, then the last four
 numbers of his or her social security number.⁸
- A mark in the checkbox affirming that the applicant has not been convicted of a felony or that, if convicted, has had his or her civil rights restored.
- A mark in the checkbox affirming that the applicant has not been adjudicated mentally
 incapacitated with respect to voting or that, if so adjudicated, has had his or her right to vote
 restored.
- The applicant's signature or a digital signature transmitted by the Department of Highway Safety and Motor Vehicles.

The term "legal residence" is not defined in the Florida Election Code; however, the term has been defined in case law. A legal residence "is the place where a person has fixed an abode with the present intention of making it their permanent home." According to the Florida Supreme Court a "legal residence consists of the concurrence of both fact and intention."

Supervisors of elections (supervisors) act as the receiver and custodian of new voter registrations, as well as the receiver and custodian of any changes in the status of current registered electors within their respective counties. ¹³ Each supervisor must maintain a list of valid residential street addresses ¹⁴ for the purpose of verifying the legal addresses of voters residing within his or her county. ¹⁵

III. Effect of Proposed Changes:

CS/SB 1360 defines the term "address of legal residence" for purposes of the Florida Election Code. It defines "address of legal residence" to mean the legal residential address of the elector and includes all information necessary to differentiate one residence from another, including, but not limited to, a distinguishing apartment, suite, lot, room, or dormitory room number or other identifier.

The bill requires the voter registration application to include the applicant's address of legal residence in order to be considered complete. However, the bill states that failure to provide a distinguishing apartment, suite, lot, room, or dormitory room or other identifier on a voter registration application does not impact a voter's eligibility to register to vote or to cast a ballot. The bill also provides that failure to provide a distinguishing apartment, suite, lot, room, or dormitory room or other identifier on a voter registration application may not serve as the basis for a challenge to a voter's eligibility or reason to not count a ballot.

Lastly, the bill requires supervisors to include within their list of valid residential addresses, to the maximum extent practicable, information necessary to differentiate one address from another, such as an apartment, suite, lot, room, dormitory room number, or other appropriate identifier.

(Executive Order of Suspension)

WHEREAS, Shawn Leigh Rowland (a.k.a. Shawn Leigh Boyle) is presently serving as a Notary Public of the State of Florida; and

WHEREAS, on or about April 8, 2013, Shawn Boyle was convicted in the Circuit Court of the Eighteenth Judicial Circuit, in and for Brevard County, in case number 2012CF060179, of one count of Acting as an Insurance Agent with a Suspended or Revoked License, a third-degree felony in violation of Section 624.310(8), Florida Statutes; and

WHEREAS, during the investigation by this Office, it was discovered that Shawn Boyle had changed her legal name to Shawn Leigh Rowland, and had failed to update her commission and notify the Department of State within 60 days, as required by Section 117.05(9), Florida Statutes; and

WHEREAS, Shawn Boyle failed to notify the Department of State of the above-stated change to her criminal history record following her felony conviction while commissioned as a Florida notary public, as required by Section 117.01(2); and

WHEREAS, on January 9, 2014, and January 24, 2014, this Office notified Shawn
Boyle by certified mail, and required that she respond to the investigation by this Office of her
felony conviction while commissioned as a Florida notary public; and

WHEREAS, during the investigation by this Office, it was discovered that Shawn Boyle had moved from the address on file and had failed to notify the Department of State of the change in her address within 60 days, as required by Section 117.01(2), Florida Statutes; and

WHEREAS, to date, this Office has not received the required response from Shawn Boyle; and

WHEREAS, the Governor is authorized by Article IV, Section 7 of the Florida Constitution to suspend from office by executive order an appointed public official for the commission of a felony; and

WHEREAS, it is in the best interests of the citizens of the State of Florida that Shawn

Boyle be immediately suspended from the public office, which she now holds, upon the grounds
set forth in this Executive Order;

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, pursuant to Article IV, Section 7 of the Florida Constitution and Section 117.01(4), Florida Statutes, find and state as follows:

- A. Shawn Boyle is a duly appointed Notary Public of the State of Florida, pursuant to Section 117.01, Florida Statutes.
- B. Shawn Boyle is commissioned as a Florida notary public from October 25, 2011, through October 24, 2015.
- C. Shawn Boyle was convicted of a felony in Brevard County in 2013, while commissioned as a Florida notary public.
- D. Shawn Boyle failed to notify the Department of State of the change to her criminal history record following her felony conviction in Brevard County in 2013, as required by Section 117.01(2), Florida Statutes.
- E. Shawn Boyle failed to update her commission and notify the Department of State within 60 days of the change to her legal name, in violation of Section 117.05(9), Florida Statutes.

- F. Shawn Boyle failed to notify the Department of State within 60 days of her change of address, in violation of Section 117.01(2), Florida Statutes
- G. Shawn Boyle refused to cooperate or respond to an investigation of notary misconduct by the Executive Office of the Governor, as required by Section 117.01(4)(c), Florida Statutes.

BEING FULLY ADVISED in the premise, and in accordance with the Florida Constitution and the laws of the State of Florida, this Executive Order is issued:

Section 1. Shawn Boyle is suspended from the public office which she now holds: Notary Public of the State of Florida.

Section 2. Shawn Boyle is prohibited from performing any official act, duty, or function of this public office; from receiving any pay or allowance; and from being entitled to any of the emoluments or privileges of this public office during the period of suspension, which shall begin today until further Executive Order is issued, or as otherwise provided by law.

SPECIAL MASTER'S FINAL REPORT

THE SENATE HAS RECEIVED EXECUTIVE ORDER NUMBER 14-111 SUSPENDING SHAWN LEIGH ROWLAND FROM THE OFFICE OF NOTARY PUBLIC. THE GROUNDS FOR THE SUSPENSION ARE THAT SHAWN ROWLAND FAILED TO PROVIDE NOTIFICATION OF CHANGES IN HER CRIMINAL HISTORY, HER NAME, AND HER ADDRESS AS REQUIRED BY FLORIDA STATUTES. PURSUANT TO SENATE RULE 12.7 AND 12.9, A HEARING WAS HELD ON THE EXECUTIVE SUSPENSION. AFTER HEARING ARGUMENT OF THE PARTIES AND AS FULLY SET FORTH BELOW, I BELIEVE SUFFICIENT GROUNDS EXIST TO SUSTAIN THE SUSPENSION AND REMOVE SHAWN ROWLAND FROM THE OFFICE OF NOTARY PUBLIC.

BACKGROUND:

On March 25, 2014, the Governor issued Executive Order Number 14-111 suspending Shawn Leigh Rowland, also known as Shawn Leigh Boyle, from the office of notary public for the State of Florida and from performing any official act, duty, or function of that public office; from receiving any pay or allowance; from being entitled to any of the emoluments or privileges of the public office during the period of suspension.

As grounds for the suspension, the Executive Order presents the following findings as justification:

- A. Shawn Boyle is a duly appointed notary public of the State of Florida, pursuant to section 117.01, Florida Statutes.
- B. Shawn Boyle is commissioned as a Florida notary public from October 25, 2011, through October 24, 2015.
- C. Shawn Boyle was convicted of a felony in Brevard County in 2013 while commissioned as a Florida notary public.
- D. Shawn Rowland failed to notify the Department of State of the change to her criminal history record following her felony conviction in Brevard County in 2013 as required by section 117.01(2), Florida Statutes.
- E. Shawn Rowland failed to update her commission and notify the Department of State within 60 days of the change to her legal name in violation of section 117.05(9), Florida Statutes.
- F. Shawn Rowland failed to notify the Department of State within 60 days of her change of address in violation of section 117.01(2), Florida Statutes.
- G. Shawn Rowland refused to cooperate or respond to an investigation of notary misconduct by the Executive Office of the Governor, as required by section 117.01(4)(c), Florida Statutes.

Hearing

I was appointed by President Gardiner to serve as special master for this matter on March 12, 2015. Pursuant to Senate Rule 12.7, a special master "shall make inquiry or investigation and hold hearings, as appropriate, and advise the President and the Senate with a recommendation and the necessity for deliberating the subject in executive session." In accordance with Senate Rule 12.9, I held a special master hearing on April 3, 2015, preceded by a single prehearing conference. Jack Heekin, Assistant General Counsel over the Notary Section of the Office of the Governor, was the Governor's only witness. Shawn Rowland appeared at the hearing via teleconference.

Executive Order 14-111 alleges several potential violations, which, if proven to be true, could serve as justification for

suspension and removal of Shawn Rowland from office; however, at the hearing, counsel for the Governor only argued three violations in the presentation of his case:

- 1. Shawn Rowland failed to provide written notification to the Department of State of the change in her criminal history within 60 days, as required by section 117.01(2), Florida Statutes.
- 2. Shawn Rowland failed to provide written notification to the Department of State of the change in her name within 60 days, as required by section 117.01(2), Florida Statutes.
- 3. Shawn Rowland failed to provide written notification to the Department of State of the change in her home address within 60 days, as required by section 117.01(2), Florida Statutes.

Applicable Law

Section 117.01, Florida Statutes, sets forth the procedures for appointment, application, suspension, and revocation of commissions for notaries public. As part of the application for a notary public, the applicant must inform the Governor whether he or she has been "convicted of a felony, had adjudication of guilt withheld, or [is] on probation." *Notary Public Commission Application*, Question 6; see also s. 117.01(2), Fla. Stat. Moreover, a notary public is obligated to "notify, in writing, the Department of State of any change in his or her business address, home telephone number, business telephone number, home address, or criminal record within 60 days after such change." Section 117.01(2), Fla. Stat.; see also s. 117.05(9), Fla. Stat.

Notaries public are public officers subject to suspension from office by the Governor for "malfeasance, misfeasance, neglect of duty, drunkenness, incompetence, permanent inability to perform official duties, or commission of a felony." Article IV, s. 7(a), Fla. Const.

Grounds constituting malfeasance, misfeasance, or neglect of duty include, but are not limited to, the following:

(g) Failure to report a change in business or home address or telephone number, or failure to submit documentation to request an amended commission after a lawful name change, within the specified period of time.

Section 117.01(4), Fla. Stat. After a notary public has been suspended, the Senate may remove the notary public from public office or reinstate the notary to office. Article IV, s. 7(b), Fla. Const.

FACTUAL FINDINGS:

Shawn Leigh Boyle, now known as Shawn Leigh Rowland, was issued a notary commission on October 25, 2011. She began her four-year term of office as a notary public on that day. The Office of the Governor and Ms. Rowland stipulated to the following facts:

- 1. On April 8, 2013, Shawn Leigh Boyle pled nolo contendere to acting as an insurance agent with a suspended or revoked license, a third-degree felony. Adjudication of guilt was withheld.
- 2. On October 11, 2013, Shawn Leigh Boyle changed her legal name to Shawn Leigh Rowland.
- 3. On October 11, 2013, Shawn Leigh Boyle submitted an application to renew her driver's license under the legal name "Shawn Leigh Rowland" and updated her legal residence to 55 Needle Boulevard, Apartment 81, Merritt Island, Florida 32953.

On March 24, 2014, Shawn Rowland notified the Notary Certification Section of the Division of Corporations with the Department of State of her address and name change. The update to her notary commission followed contact initiated by the Notary Section in the Office of the Governor concerning changes in Shawn Rowland's criminal history.

At the hearing, counsel for the Governor conclusively established that Shawn Rowland failed to provide the required written notice of her change in criminal status, her name change, and her address change.

Shawn Rowland did not dispute these facts presented by counsel for the Governor, but provided additional background and explanation and a plea for leniency. Under oath, she

presented information concerning the difficult challenges she was facing at that time in her life. I found Shawn Rowland to be a credible witness and accept her testimony as true.

Specifically, she relayed that during 2013 she was embroiled in divorce proceedings. Also during this time, the State Attorney was pursuing charges against her based on an assumption that she was performing services as a title agent. She initially contested the charges. Although she was performing title work at the time, she nevertheless contended she was not performing the work of a title agent. After several continuances of her criminal trial, the continued prosecution and her divorce were taking its toll. To bring closure to the ordeal, Shawn Rowland accepted a deal to plead nolo contendre, withholding adjudication of guilt. Her public defender advised her that she would not have to report the plea as a conviction because adjudication of guilt was not imposed. Based on that advice, she was not aware that she was obligated to report the criminal charge and resolution of the matter.

Around the time Shawn Rowland changed her name and address, she was unemployed and not utilizing her notary commission. She further testified that she had not used her notary commission since changing her name.

CONCLUSION:

Based on the foregoing, it is my opinion that counsel for the Governor has demonstrated appropriate grounds for Shawn Rowland to be suspended and removed from office. I make this finding based upon a clear violation of the law. As counsel for the Governor argued, notaries public are public officers subject to a higher standard. My recommendation is based on the law and the facts as proven. While Shawn Rowland presented as a sympathetic and credible witness, it is not my role to say whether leniency or a lesser penalty should apply. This conclusion and report is only a recommendation to the President and the Senate. If leniency or mercy is to be granted, it is within the power and discretion of the Senate to grant it.
