### Gaming

Gaming is an established business sector in Florida; its roots stretch back to the 1890s. Recent rapid changes have transformed gaming industries, but laws and tax policies have not kept pace. The situation demands a comprehensive critical assessment.

The Senate Gaming Committee has assembled a wealth of information, including Spectrum's <u>Gambling Impact Study</u> (PDF), insightful and diverse testimony at public workshops across the state, and more than 1,500 online comments. In January, the committee will begin considering market-driven solutions that will promote Florida's overall economic and social welfare and address ambiguities and inconsistencies in current statutes.

### Florida Gambling Impact Study

The Senate and House jointly commissioned a two-part gaming study to set a factual foundation for important policy choices the Legislature will consider during the 2014 Regular Session. The final report (PDF) is 708 pages (approximately 8.5 MB).





Tallahassee's 12 9 2013 Senate Gaming Study Committee Good Afternoon Mr. Chairman, Ladies and Gentlemen of the Committee.

I am representing the Florida Greyhound Association and the National Greyhound Associations for their interest in Florida.

I would like to thank Senator Gatez and you Mr. Chairman for the format of the Committee Meetings that you have held around the State in your listening tour. I would also like the thank The Members of the Committee for attending all or some of the meetings.

Today I would like to do a brief summary of the meetings as they pertain to Live Greyhound Racing and give your staff some supporting documents.

<u>In Broward County we heard</u> from that the <u>"Gambling Impact Study" found:</u>

- Parimutuels employ over 7,000 Floridians
- The State Revenue is over \$200 Million

You're Department of Business of Professional Regulations, Division of Par-Mutuel Wagering Annual Report found:

<u>Total Greyhound revenue to the State increased by 11%</u>
 <u>last year to almost \$10 Million Dollars</u>. Unfortunately the current Tax Policies gave away an additional \$12 Million in Tax Breaks to some Greyhound Track Operators.

- As an example in the summer month of August Greyhound Handel was up over \$1 Million Dollars to over \$20 Million in the summer month of August.
- The Handel on <u>Live Greyhound Racing was up over</u> \$650,000 in August.

In Broward and around the State we heard from a Cult like Group from Mass. Called Grey2K and their follower's repeat well orcastrated but false information.

Mr. Chairman Ladies and Gentlemen of the Committee there is no such thing as "Decoupling"! That is P R phrase by some misguided Track Operators that want to eliminate live Greyhound Racing so that they can create 13 Casinos around the State.

Eliminating Live Greyhound Racing would put over 8,000 beautiful Greyhounds and thousands of Floridians Jobs at risk.

The People of Florida Voted for Live Greyhound Parimutuels. If you want to change that I would respectfully recommend that you let the People of Florida Vote on and let the people in each of the 13 Communities Vote on it in a General Election.

In Lakeland we learnt that the Mass. Cult had appeared at meetings with the Animal Liberation Front, a group the FBI considers a Domestic Organization. A copy of the FBI Report will be submitted to your staff.

We also began to hear how well treated the Racing Greyhound is and that over 95% are Adopted or return to the Farm to live out their lives. This is the standard that the No Kill movement is trying to get all of your local Animal Shelters to reach. Similar to what Manatee, Miami Dade, Broward and Jacksonville are working towards.

<u>In the Republic of West Florida – Pensacola</u> we put forth a 3 point plan for real Greyhound Safety.

Giving the Department of Professional Regulation clear Statue authority to;

- 1. Require all Tracks maintain proper Track Surface; the U of F Vet School can help in developing this standard.
- 2. Require all Greyhound Tracks install a safety device to remove the lure from the racing surface via remote control similar to the <u>Redhound Racing Safety Devices</u> that has been 100% successful in avoiding injures at the Palm Beach Kennel Club.
- 3. Require ALL Greyhound Tracks insulate the cooper bus bar that is currently exposing 240 volts to man and animal. Can you even image that we have 240 volts exposed to man and animals in this day.

### And Finally Mr. Chairman in Jacksonville

We heard that your "Gambling Impact Study" had found that an Advanced Deposit Wagering facility that is owned by 3 Florida Parimutuel Facilities did over \$2 Billion in handle much of that diverted from Florida Tracks. That ADW Handel is up 47% since its inception while the Florida Parimutuel Handel is down 41%.

Some Florida Tracks even encourage their patrons to place bets on live Florida Races through an out of State ADW facility that they own costing the State of Florida and its Citizens Millions in currently required lost revenue.

And we went on our I phone to the Palm Beach Kennel Club Web site then clined on and went to Oregon. Betting on a Florida Race in Florida but not paying Florida Taxes that are currently owed. This could be costing you the State of Florida \$500 to \$100 Million Dollars.

Therefore Mr. Chairman we would respectfully recommend that you order the Department of Bushiness and Professional Regulation to conduct a forensic audit of any and all Florida Parimutuel Facilities that own or control directly or indirectly an out of State Advanced Deposit Wagering (ADW) Facility to be sure the State of Florida is getting all of the Revenue that it is owed under current Law.

# Putting Intel to Work Against ELF and ALF Terrorists

In early 2006, eco-terrorist Eric McDavid and two associates met in a secluded cabin in Dutch Flat, California to discuss making improvised explosive devices and to choose targets to bomb. Soon after, they began casing the targeted facilities and buying supplies to make bombs. But before they started mixing the ingredients, we swooped in and arrested them.

How did we know what McDavid was up to? How were we able to prevent attacks that could have caused thousands or millions of dollars in property damage and possibly harmed people?

#### In a word, intelligence.

Our intelligence—which included the use of an FBI source who was actually with McDavid and his associates inside that California cabin—allowed us to piece together the entire plot ahead of time.

Since 9/11, we have greatly strengthened our ability to identify, collect, analyze, and share intelligence across all of our national security and criminal priorities. And that has carried over into our investigations of violence and terror committed in the name of the environment—as well as of animal rights.

Together, eco-terrorists and animal rights extremists are one of the most serious domestic terrorism threats in the U.S. today...for several good reasons:

- The sheer volume of their crimes (over 2,000 since 1979);
- The huge economic impact (losses of more than \$110 million since 1979);
- The wide range of victims (from international corporations to lumber companies to animal testing facilities to genetic research firms); and
- Their increasingly violent rhetoric and tactics (one recent communiqué sent to a California product testing company said: "You might be able to protect your buildings, but can you protect the homes of every employee?").

**ELF** and ALF are probably the names you're most familiar with. The Earth Liberation Front (ELF) and the Animal Liberation Front (ALF) are loosely-organized movements whose adherents engage in crimes like arson, fire bombings, vandalism, intimidation, assaults, stalking, etc. No membership dues are necessary—the only way to become a "member" is to engage in "direct action"...criminal activity designed to cause economic loss or destroy the victim company's operations.

#### So what are we doing to counter the threat?

For one, we've mapped our environmental and animal rights extremism cases in order to give our investigators around the country and our executive management a big-picture look at what's happening and where. We're also analyzing information from financial records, phone records, and mail...and working to increase our human source reporting. And we're sharing intelligence with our partners through our Joint Terrorism Task Forces and other investigative endeavors. Sharing info with our partners, particularly at the local level, is crucial because many times they're the first ones at the crime scene.

We're also taking advantage of the 2006 revision to the Animal Enterprise Terrorism Act, which toughened penalties, created additional protections for people (the original law only covered property damage), and included secondary targets (often times companies that do business with primary targets are themselves targeted).

Our efforts have paid off—since 2005, our investigations have resulted in indictments against 30 individuals.

Of course, fully cognizant of the right to free speech, we investigate all animal rights and environmental extremism cases in strict accordance with the law and our guidelines.

**So whatever happened to Eric McDavid?** In May, he was sentenced to nearly 20 years in federal prison.



For the past 16 years, Beverly has served as CEO and president of the National Greyhound Foundation Inc. (NGF), founding and guiding it from a small nonprofit greyhound-adoption organization into a nationwide program. In October 2005, while searching for a way to save thousands of greyhounds that were being killed yearly. Beverly developed a new program called Second Chance at Life: Greyhound Prison Partnership that not only benefits the greyhounds but also helps incarcerated men and women. This training program pairs dogs with prisoners, who help socialize and train the animals so they can be placed with a loving family. This unique prison program is being replicated in correction facilities across the country and gives inmates the chance to learn compassion and lifestyle skills and build self-esteem while saving the life of a retired racing greyhound. This program affects the lives of not only the inmates but of all the staff at the prison. NGF created and operates the only national recidivism database in the country with this human/animal connection program. According to their first report, out of 14 inmates released, only one inmate returned to prison, Before founding the National Greyhound Foundation. Beverly spent 26 years in the movie industry. She was nominated Woman of the Year by the National Greyhound Association in October 2010. The satisfaction from the work she does with the greyhounds comes from the hundreds of letters from inmates telling her how much they appreciate the programs and what they have learned. They spend \$54 million dollars a year creating good publicity. They know the damage of bad publicity.

6. Impact on future tourists...There are 83.3 million people representing 47% of American households that own dogs in this country. And there's no one as passionate as real animal lovers.

A State that allows killing greyhounds would be on the bottom of their list when planning their vacations.

- 7. Information on number of greyhounds is all over the place. No one will say for sure how many there are. Tracks and other organizations say that all greyhounds will be adopted. HOW? And what will it COST? And who will pay for relocating 21,000 greyhounds.
- 8. Has anyone presented a plan and answered the above questions?
- 8. I did a Feasibility Study last year that produced a solid plan and created a budget, a schedule, and a breakdown of the cost to adopt 1200 dogs at one track and relocate them to their forever homes. The cost was \$697,000.00 for one month. And that's only one track. Add another 7000 greyhounds on the farms, management and advertising cost to get the dogs adopted and you can see the cost.

- 9. If Decoupling becomes law without stiff controls on track owners and a schedule to get these dogs adopted, it will create a tsunami of dead greyhounds like you've never seen and be a PR disaster for Florida.
- 10. The Future: If greyhound racing can no longer support itself, then it should be phased out. I've heard that the tracks do not want to phase it out but that's the only humane way to phase out an industry. It's more than greyhounds, its people too.
- 11. Where will the money come from to support decoupling and its consequences?

W ho benefits the most from stopping greyhound racing? The tracks and the Casino interests. The cost of saving these animals lives, and assisting and retraining the unemployed like you did in the NetBan, is a small price to pay for the potential revenue gambling interests will derive from Florida.

I've spent 25 years sitting across the table from many tough negotiators in the movie industry like Paramount Studios and Warner Bros. executives and believe me, they were some tough negotiators. But I've never negotiated a deal where everyone wasn't a winner and walked away from that table satisfied. If I can do it, so can you. So, please, Put the politics away, find away to give everyone concerned at least a part of what they want, and put the greyhounds first.

Honesty in gambling

The gambling debate has given rise to a lot of misinformation about the gambling issues, along with some very cleverly calculated confusion. Soapy Smith, the legendary king of the con men in the gold rush days, would be envious.

The general public is woefully undereducated about gambling. Most know how to play a few games but know very little about the industry as a whole. And those who are in a position to reap huge profits from the gamblers are in no hurry to inform the people how it all works. Their motto comes from a W.C. Fields character, Larsen E. Whipsnade: "Never give a sucker an even break or smarten up a chump."

In the past couple of years there have been several local votes in favor of having slot machines at horse tracks, dog tracks and the jai-alai frontons. The owners of these facilities are quick to point out that the citizens passed these referendums by large margins.

But in reality the vote was rigged. The gambling public definitely wants to play slots. It's the biggest gambling venue of all time. But on the ballot the only choice was play at the track or don't play at all.

The ballot should have given an honest choice to the gamblers: If you approve of the public being allowed to play slots, where do you think they should be able to play? At the track, the local mall, slot parlors in strip malls, recreation centers, retirement communities, or other places where people go for recreation? If that had happened, the votes might have turned out quite different. There is no question the people want to play, and they should be given the opportunity.

The tracks and frontons would be great venues for slot machines, but having an exclusive deal over other businesses and recreational facilities is suspect.

Internet sweepstakes cafes are businesses that entertain people for a price. "Come to my place, pay me some money, and have yourself some fun." So people go (of their own volition), pay the money, and have some fun.

The providers of gambling are so far ahead of the lawmakers it's embarrassing. They employ smart people from many fields who have developed many systems allowing them to circumvent the poorly written laws.

It's time to make the gambling laws fair, honest, and for everyone. Treat it as a normal business. Buy a license, pay your taxes and compete like everybody else. If people don't want to gamble, it will soon disappear.

Let's take another look.

A majority of negative concerns when discussing gambling and casinos tends to focus on increase in crime rates, increasing bankruptcies, and increases in compulsive gambling behavior. Some recent studies support this thinking, but the truth might be in the details. Another look at the facts reveals another story.

The studies of crime rates associated with gambling facilities generally report a 10% increase, give or take a point or two. That means 90% of those indulging in gambling are doing so with no problem.

Bankruptcies reportedly increased less than 1% when gambling opportunities became available.

Problem gambling is reported to be about 8% to 10% of the gambling public, depending of the definition, with compulsive gamblers making up about 2% or less of the total. This means over 90% of the gamblers are gambling and enjoying the experience with little difficulty.

Maybe a little more focus should be placed on the 90+ percent of the gamblers who are providing over a billion dollars per year to the state. In most cases a 90% success rate is more than acceptable.

It is feasible and plausible. The positives far outweigh the negatives.

With the economic ills of today, there's no better time to legalize casinos statewide, or at the least, place it on the referendum ballot.

In recent times, the State was forced to cry uncle in its battle with the Seminole Tribe. Inconsistent and shoddy gambling laws passed over the years; (an effort to protect a few private enterprises), helped the Seminoles prevail. After the U.S. Supreme Court pointed out the errors of their ways, the State partnered with their enemies; smoked the peace pipe; and took a cut of the profits.

The practice of handing out sweetheart deals to the old favorites, so they can reap the mega profits gambling has to offer, needs to end. This back scratching process, served its purpose in the past, but times have changed.

Can the legislature re-write the gambling laws without favoritism, cronyism, back scratching and sweeteners? Can they construct fair and equitable laws and regulations? Call your bookie and get in on the early line; 55 to 1 against.



#### Ambiguous gambling laws

So the sheriff is shutting down the sweepstakes cafes. No one to blame here but the state Legislature. If the sheriff shuts them down or leaves them open, it's the ambiguous gambling laws that have created this problem.

Marianne Pasha gave a standard rendition of the definition of gambling. No problem there. The gambling activity as her definition describes it, is legal in Florida. Examples: horse and dog tracks, casinos, poker rooms, lottery games, bingo, and poker rooms. So all of the rhetoric about what is considered as gambling, and that gambling is illegal, quickly becomes a moot point.

So what is it that's illegal? If it's not the act of gambling, and it's not the games, what's left?

Law enforcement is left chasing the gray area of the state's gambling laws, which allows certain people, in certain places, to offer certain gambling games to some citizens. There is no defendable rhyme or reason to these decisions. For the other citizens of Florida who wish to gamble in other ways the state cries foul. This is done under the guise of "gambling is illegal." The gray area of the law is not as gray as it is favorable to some private citizens. The act of gambling is not illegal. Not being on the "special list" of people who are given the right to offer gambling to the public is what's illegal.

There are some clear and well-defined illegal activities that are a part of the gambling attraction. These are known as the "blood sports." These activities still take place in some communities, but are not approved in any way by the state. Dog fighting and cock fighting is a definite no go. Bull fighting, rat baiting, cricket and spider fighting, even canary fighting is clearly against the law along with many other such horrors.

So it is demonstrated that a clear picture is attainable about what is illegal and what is not, when it comes to certain activities and gambling on those activities. The sheriff would not feel a need to send a notice to a person operating a cock-fighting pit giving him 30 days to show why he should not be closed and put in jail. Moving the operation to another location to avoid prosecution might not work either. Disguising a bullfight as an animal exercising period might not pass muster. There has been no precedent set that would allow a county or a sovereign nation or a pari-mutuel facility to have any animals fighting to the death; betting or no betting. And no one is seriously lobbying to get these activities approved.

Most of the other gambling games have no real basis for being outlawed, or they would be outlawed everywhere. Why can a person bet on a horse or play in a poker game, even play a slot machine, all in the same facility, but a roulette game is outlawed? It's just that the present system is trying to have it both ways. Florida citizens are beginning to see through the charade of current gambling laws.

People will be looking back at the sweepstakes cafe gambling issue and wondering what level of thinking was in play on both sides of this hypocrisy.

The Florida gambling laws have evolved over the past 90 years and are now crumbling because of their own inequities. The laws have been written over the years to favor individual groups, individual people, certain locations, and collect money for certain causes.

Never written because there was a firm belief that gambling was good or evil. If that were the case Florida would have no legal gambling, like Utah, or wide open gambling, like Nevada.

In 1935 over \$60 million dollars was added to Florida's bank account from legal slot machine action. In 1940 the state added an extra 2% tax on Dog Tracks and Frontons for the "Old age assistance fund. And on and on it went.

Florida has legal gambling, tacit gambling, and illegal gambling, and now the internet or electronic gambling is coming of age. Writing new gambling laws covering this new arena will not be easy.

It's a given that taking the NYC Mayor LaGuardia approach, confiscating the gambling equipment and dumping them in the ocean will be a step back in time. LaGuardia was considered one of the best American city mayors in history, but this action hardly slowed down gambling.

It's time for some education about gambling for everyone and its time the lawmakers made laws governing gambling that applies to everyone.

Gambling and control, a theme first raised by Croson, was taken up again but with a very different slant in presentations by Kathryn Tanner, a University of Chicago theologian, and T.J. Jackson Lears, a historian from Rutgers. In a society such as America's, where risk is spread unevenly and only the wealthy can hedge their bets, gambling gives individuals of lesser means "at least the illusion of being in control of [their] fate," Tanner said. While the odds may be long, she said, the lottery or the slots are a rare source of hope for a new beginning for the poor and the unemployed.

Lears went further. In what was probably the conference's boldest and most controversial paper, he argued that gambling was central to an alternative culture in America, "the culture of chance," which he contrasted favorably with the dominant "managerial culture of control." While admitting that he finds casinos depressing, he nevertheless likened contemporary gambling to the ancient practice of sortilege—"casting lots . . . to determine the will of God." In a sly hint that clinicians who pathologize gambling are indulging their own class prejudice, he pointed out that day trading and currency speculation "remain untainted by the language of pathology." Lears also suggested that for at least some players, gambling, with its near-inevitable losses, may be quasi-religious, an unrecognized form of renunciation.

Mr. Terril,

I apologize for taking so long to get back to you on your question about decoupling and the operations at Tampa Greyhound. The litigation load has been unusually high for this time of year and has taken me out of the office. However, your question is important and I know I need to be sure you have an adequate response.

Sect. 550.475, Florida Statutes, allows pari-mutuel permitholders to lease the facilities of a similar pari-mutuel permitholder that is located within 35 miles to operate their live racing. Tampa Greyhound has been operating their live races at St. Pete Greyhound under a license from the division authorized by this section for the past few years. Therefore, the racing required to operate their poker room is happening, just at a different location within the local area.

By copy of this e-mail, I am asking that Ms. Polombo send you a copy of a declaratory statement issued by the division on this issue. [Mary – This is the Jacksonville Kennel Club Declaratory Statement with Tampa Greyhound as an Intervenor].

The declaratory statement was originally requested by Jacksonville Kennel Club and involves some issues which are not relevant to the information you requested, but the statement does include the division's analysis of the statutes relative to operating racing under the leasing statutes and the ability to continue card room operations at the original permit location. Tampa Greyhound intervened in the declaratory statement in order to be sure that they could operate under a lease at St. Pete and continue card room operations at the Tampa Greyhound facility.

I hope this is helpful in answering your questions.

No need to apologize, I understand the pressures of doing the governments bidding. A few years back I was busting hump for The Florida Division of Youth Services, out of the Winewood Office.

I want to thank you for taking the time to answer this minor question about the activities at the Tampa Dog Track. It's almost a non-issue, since it has already gone on for six years. Seems clear to me nobody really cares. The gamblers would much prefer to play cards than bet the dogs. This is also clear at Derby Lane in spite of their enhanced schedule.

The coming revamping of all the gambling laws as promised by the legislature, is calling for an examining of the current legal situation.

Senate President Gaetz, at a recent news conference in Panama City was quoted as saying: "The problem we've had is that there's never been a real policy on gaming; there's been instead a kind of Band-Aid, patchwork, bailing wire and chewing gum approach." He went on to say: "It's been a series of reactionary pieces of legislation. The state enters into a compact with the Seminoles; then racinos (pari-mutuels that offer table games) say there's a competitive imbalance. A fix is made, but another imbalance is claimed elsewhere. It's always a kind of reactive, defensive addition of a shanty or lean-to onto what is [in place], as opposed to stepping back and seeing what ought to be or what might be."

The decoupling issue at the Tampa/St. Pete tracks, and others around the state, surely falls under Senator Guetz categorization. It seems that this deal has little to do with dog racing.

The "Petition for Declaratory Statement" was an eye opener, but not a surprise. It has been a long time political maneuver in Florida to protect the pari mutuels from competition and protect the tax revenue for the state.

Not exactly a professional way to make fair and equitable laws governing gambling, but it gives us proof of the "Gaetz Theory."

In the many points of discussion a few questions stood out; why 35 miles? What does 35 miles bring to the table that 60 miles, or 10 miles doesn't? How does leasing your race dates at another track, equate to having live racing? (If you asked 1,000 average people what live racing meant, 999 would agree it would be racing in their presence.)
How can you receive a dog racing permit it you have no track?

Is this a set of laws full of loopholes? Does it look like the laws were written to protect certain businesses while being able to exclude others? In a free enterprise system, should the government be in the business of protecting profits for private business?

I'm sure there will be many more interesting "takes" on these issues.

The students are totally confused about Florida Gambling law, but they are getting an eye opener about the politics of law making! Follow the money.

The lotteries purposely mislead players about their chance of striking it rich. One study found that 70% of television advertisements portrayed people winning. Moreover, the study noted that states purposely disguised the odds and, in fact, gave the impression that there existed a good chance of winning. Even some government officials have grown concerned about such tactics. In 1997, New York Governor George Pataki requested lottery officials to "tone down" their, "Hey, you never know" promotion, and added that lottery marketing should avoid "raising unrealistic expectations." One might ask, is there no law to stop such deceptive commercials? Of course, the Federal Trade Commission has "truth-in-advertising" standards. Yet because lotteries are state entities they are not bound by the same requirements to which private businesses must comply.
