This week, I am happy to announce that the Haile Brockington Act (SB 1676) passed its first committee stop. When I first heard of Haile Brockington's tragic and needless death, I was enraged as both a mother and a Senator. Since then, I have worked tirelessly to ensure that parents across the State of Florida will never have to experience such a tragedy.

This bill will ensure that those who are entrusted with driving thousands of our children to and from school and daycare everyday will check and make sure that every child has been safely removed before closing their vehicle. This is accomplished by a simple alarm placed in the back of the vehicle that sounds after the vehicle is shut off, prompting the driver to inspect the vehicle for children.

I am extremely proud of what this bill accomplishes, and am emboldened each day by those who reach out and lend their voices to help in this fight to end hot-car deaths in Florida. Two more stops remain until the Senate floor, and in Haile's memory I will never give up.
