<u>Marion Technical College is credentialed by Council on Occupational Education (COE).</u> MTC is required to conduct annual student follow-ups upon completion of a program. The follow up process requires MTC maintain a minimum 60% program completion rate, 70% program job placement rate, and a 70% Licensure/Certification rate. Failure in any area places program on probation and a program improvement plan is required. If no improvement occurs in year two, the program is triggered for one year.
