11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The project will enhance and improve environmental and wildlife quality, protect the general public from harm, improve transportation conditions, increase and improve economic activity, increase tourism, create immediate job opportunities, improve physical health, improve storm water management, and improve groundwater and surface water quality.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

<u>Heavy rain events result in poor drainage to the area.</u> Medical transportation providers need unimpeded access to the area. A significant number of elderly residents live in the area and rely on medical transportation to hospitals and doctors. When flooding occurs, medical transportation is suspended. Standing water for extended periods of time results in mosquito breeding causing a health risk. The street area is next to two major parks. Health concerns are elevated with Zika Virus. The project will improve the quality of the storm water entering the Intracoastal Waterway and enhance the wildlife habitat with the water treatment component of the project. The pump station will prevent salt water from entering the drainage system and flooding roads and swales, which currently kills grass and keeps the ground soggy. Because the roadway remains free from flooding and ponding water with this project, the US-1 Corridor Mixed Use District economic development initiatives can move forward.

<u>Roadway surfaces remain free of flooding and ponding water during significant rain events</u>. Roadways remain passable and safe. No residual standing water remains on road surface or along driveway aprons. High rise condominium developments will be constructed. Private investment of several hundreds of millions of dollars on the waterfront will occur. By treating water before it's discharged into the Intracoastal Waterway, the quality of the ground water will improve significantly. The pump station will prevent salt water from the Intracoastal from backing up into the swale areas and driveway aprons, as it currently does. Palm Beach County and South Florida Water Management District monitor water quality.
