To address these daily struggles and adverse outcomes of children with incarcerated parents, A Vision of Redemption's (AVOR's) Family Reconnection Program (FRP) is built on evidence based best practices and includes the following components: •Using the Parenting Inside Out Curriculum to help returning citizens improve relationships with their children and spouses or significant others; •Providing Storybooks to returning citizens and their children to serve as icebreakers for the first visit and promote family literacy for the first and subsequent visits; •Assisting in transporting children and their caregivers to and from prison for regular,



monthly visits with incarcerated parents; and •Hosting a support group for caregivers so they can share their experiences and access other resources to strengthen family cohesion.

•Assisting imprisoned parents with fostering and maintaining meaningful relationships; •Helping imprisoned parents and their children build vocabulary and literacy skills; •Assisting children in learning patience, developing listening skills, and using their imaginations; •Facilitating visitations to aid in the management of the inmate population . 1.Recidivism: By December 31, 2018, 75% of the returning citizens participating in the program will not have been convicted of any new crimes/ behavioral infractions, as measured by reviews of returning citizens' criminal records; 2.Returning Citizens' Literacy: By December 31, 2018, 50% of the returning citizens participating in the program will have improved their literacy skills by at least 25%; as indicated by a pre-/posttest comparison of performance on the prison component of the National Assessment of Adult Literacy (NAAL) Survey; 3.Child Literacy: By December 31, 2018, 50% of school-aged children (participating in a minimum of
