a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal of this project is to improve the water quality of the impaired waters of Charlotte Harbor through the removal of on-site treatment disposal systems (OSTDS) and construction of central wastewater service to these properties. El Jobean is a densely populated coastal community comprised primarily of elderly, low-to-moderate income residents located on the Myakka River, a tributary to Charlotte Harbor which is listed as impaired by EPA under section 303(d) of the Clean Water Act.

Installation of wastewater transmission lines to connect 358 properties to sewer services

d. What are the direct services to be provided to citizens by the appropriations project?

<u>Installation of transmission lines to provide central water and wastewater service to the El Jobean Community.</u>
<u>Elimination of failing OSTDS that are contributing heavily to the impairment of Charlotte Harbor.</u>

e. Who is the target population served by this project? How many individuals are expected to be served?

This community is a low-income community of mostly senior residents on a fixed income. It is expected that all 358 property owners will be served by this project.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

358 septic systems will be abandoned and connected to central sewer, which will lead to improved water quality in the impaired waters of the Myakka River and Charlotte Harbor, reduction in septic effluent in stormwater and surface water. This outcome will be measured through pre- and post construction monitoring of nutrients, bacteria and contaminants in stormwater and surface water.
