11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Reduce and or eliminate flooding from upstream residential and commercial properties in the City of Panama City Beach. FDOT is currently installing additional cross drains on US-98 to reduce peak flood stage upstream in the neighborhoods and the downstream (this project) needs to be improved to reduce historical flooding and make the new FDOT culverts effective.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The project will widen the existing 5764 LF ditch to provide greater capacity for conveyance during major storm events. The FDOT is installing three (3) additional culverts under US-98 at the ditch location that will require more downstream capacity to prevent flooding upstream. The outfall design and construction plans are completed and project is in permitting with ACOE. The DEP has granted an exemption for the project. The comments from ACOE are now being addressed and permits are anticipated in the next few months.

The existing residential and commercial properties will no longer flood or have reduced flooding - peak flood stage elevations will be significantly reduced in the upstream basin.

e. Who is the target population served by this project? How many individuals are expected to be served?

The target population is Hombre and North Glades community - serves approximately 600 residents

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Upstream flooding will be significantly reduced - measured outcome will be to eliminate upstream flooding for the existing structures. The peak flood stage will be monitored after construction is completed to develop new flood mapping for the area with accurate data for planning and analysis.

g. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The NFWFMD may eliminate funding for the project if deliverables are not met. The bidding and contract documents will include liquidated damages for the contractor if the project is not completed on time and the project will also have a 5% bid bond and 100% performance bond required.

The owner of the property is the St. Joe Company and they have granted an permanent drainage easement to the City of Panama City Beach to construct and maintain the improvements that will benefit the City and its residents.
