The Edward Waters College Promise Program is the creation of a pathway for low-income first time in college hardworking students beginning their higher education at a four-year institution. The funds will be used to cover the "last dollar" for a cohort of 100 students with a college match of 100 bus passes for transportation. The purpose is to remove the barrier of overwhelming financial debt that is incurred which prevents students from persisting in college and graduating.

# a. What is the specific purpose or goal that will be achieved by the funds requested?

The EWC Promise will consist of a cohort of 100 students with a current College investment in transportation costs and a requested need to fully fund four years of tuition, fees and books. The Program will provide financial, academic and soft-skills support for students through the creation of a 75-hour community service program inclusive of a mentor within the College and an industry external partner. National research on similar programs shows that these components and criteria create successful student persistence and degree completion of the cohort.

# b. What are the activities and services that will be provided to meet the intended purpose of these funds?

100 students will be provided transportation, assigned mentors and financial support to eliminate future debt as they begin work upon graduation. Students will receive coaching in academic and financial literacy to better prepare them for a successful life and career. Students will be exposed to soft-skill training including meetings and events with industry professionals for career development, internship and job placement opportunities.

<u>The 100 students will receive monthly transportation and assigned mentors within the College including a</u> mentorship arrangement with an industry partner. Students will be provided with specific financial aid and academic affairs counselors assigned to the Promise Program to ensure students receive tutors when needed to remain in academic good standing and to continue at full-time status with the goal of graduating within four years.

<u>The target population is first time in college students from low-income backgrounds who are pell grant</u> eligible. 100 students will be in the cohort.

Expected outcome is full-time students are on a yearly academic path to complete necessary credits each year with the goal of completion within four years. The purpose is to remove the financial barrier and provide a concentrated program with the mentorship component in an effort to reduce drop out rates due to student financial concerns which then impact academic success. This investment in financial and career readiness will properly prepare students for their next life phase. The methodology will be administered by the academic advisor assigned who will assist in tracking academics, community service and mentorship hours through personnel in career development. Student success will be tracked on a quarterly basis.
