- 4. Project/Program Description:

This program targets homeless veterans with criminal justice involvement, who have a mental illness or comorbidities of mental health and substance abuse. Camillus House will work with the 11th Judicial Circuit Court Veteran's Court Program to implement the program. The Camillus House Veteran's Treatment Program is designed to expand and concentrate services for veterans with criminal justice involvement related to mental health and substance abuse issues. All veterans placed into the program will be identified and referred by the Veteran's Court program. Supportive and clinical services assist veterans through several phases including: 1) crisis intervention and assessment; 2) comprehensive treatment and case management; and 3) social reintegration. Camillus will provide wraparound treatment and case management services with the aim of stabilizing these individuals.

## **11.** Program Performance:

## a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal of the Program is to support veterans in order to prevent chronic homelessness and recidivism by: 1. Stabilizing participants by providing a safe place to receive care, treatment and services to enable veterans to address their trauma and begin recovery. 2. Enhancing self-esteem and vocational skills. 3. Assisting participants to obtain employment and/or benefits to facilitate independent living. 4. Providing post discharge housing assistance to return veterans to the community.

## b. What are the activities and services that will be provided to meet the intended purpose of these funds?

<u>Supportive and clinical services assist veterans through several phases including: 1) crisis intervention -</u> providing immediate shelter as well as conducting an initial assessment to address basic needs. 2) comprehensive assessment and case management - includes a detailed psychosocial assessment conducted by professional staff to determine the behavioral health and other needs (medical, social service, etc.) needs of the client; and 3) social reintegration - life skills development, job and education support, housing navigation, family reunification and supporting independent living. The funding requested for this project will support ongoing operational expenses and staffing related to operating the 20 bed Camillus Veteran's Treatment <u>Program.</u>

# d. What are the direct services to be provided to citizens by the appropriations project?

<u>The direct services to be provided include behavioral health treatment for substance abuse and mental health</u> <u>issues.</u> Clients receive individual and group therapy to address their psychological issues as well as are provided with therapeutic/wellness activities as part of their recovery. Clients receiving case management to support job/vocational advancement, securing permanent housing, obtaining benefits and family reunification where possible.

## e. Who is the target population served by this project? How many individuals are expected to be served?

This program will benefit homeless veterans with substance abuse and mental health issues. These individuals must be homeless or at risk of homelessness and referred through the criminal justice system, or other



veteran's provider. They will typically have behavioral/mental health issues, including but not limited to posttraumatic stress disorder and/or symptoms of substance abuse; require intensive therapy, life skills and professional development training; and needing a supportive environment in which to receive treatment. The program seeks to serve approximately 45 persons each year.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Stabilizing these individuals benefits the State of Florida by ensuring that these individuals, many of whom have served during war, do not become chronically homeless. This program will also provide enhanced selfesteem and additional vocational skills that will allow these veterans to live independently. The goal is to also minimize homelessness amongst this vulnerable population. The Camillus House Veterans Treatment program will seeks to serve at least 45 unique individuals each year. Performance and outcomes will be measured as follows: 1. 70% of veterans with mental health issues participating in the Camillus Veteran's Treatment Program will successfully complete treatment 2. Average number of days worked for pay by program participants will be at least 20 3. 100% of participants will have a service plan that is updated every 30 days 4. 70% of participants will move on to permanent housing upon discharge from the program.

  <u>Camillus House expects that as with all its State funded contracts, corrective action plans may be required for noncompliance, nonperformance, or unacceptable performance under this Contract. The increments of penalty imposition that shall apply, will be determined by the contracting agency and are typically be based upon the severity of the noncompliance, nonperformance, or unacceptable performance or unacceptable performance that generated the need for corrective action plan. Current contract penalties do not exceed ten percent (10%) of the total contract payments during the period in which the corrective action plan was not implemented or in which acceptable progress toward implementation has not been made.</u>
