#### a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal is to expand the economic opportunities for low to moderate income residents in North Pinellas and West Pasco counties. The location of the training facility will be advantageous to those who lack transportation. Those individuals, who lack transportation, will be given the ability to become job ready. A report produced by Pinellas County lists transportation as an economic barrier to families obtaining the skills necessary to becoming self-sufficient. The facility will provide individuals and entry-level workers access to training as well as the workforce. The training facility will contribute significantly to providing the education and training necessary for families to get out of poverty. There is also a significant population who do not desire to go to college but need to receive additional training for jobs available in the area.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The multipurpose facility that will be constructed will be used for training as well as preparing individuals for the workforce. We will be partnering with agencies whose mission is to provide training i.e., Pinellas Technical College (PTC) and Career Source Pinellas. This facility can be a gateway from high school to learning a skilled trade. These partnerships will create apprenticeships for entry into any one of the building trades: Heating, Ventilation and Air Conditioning, Plumbing, Electrical, Carpentry, Technology, etc. In addition, the partnerships established will offer participants a chance to learn or enhance their skills.

d. What are the direct services to be provided to citizens by the appropriations project?

The direct services to be provided to citizens by the project will be training for vocational and technical jobs.

e. Who is the target population served by this project? How many individuals are expected to be served?

Residents of North Pinellas County are the primary population to be served by this project; however, the facility will be open to anyone in the Tampa Bay area. We expect to serve 300 - 500 households annually.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will provide a training facility to individuals in North Pinellas County where there is currently a void of training facilities. Also, the employers in the North Pinellas County area will benefit from having an adequate supply of trained workers. The specific measures used to document performance data are: 1) The number of participants enrolled in the training and work readiness programs; 2) The number of participants that complete the training and job readiness programs, and; 3) The number of job offers participants receive after program completion.

- g. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

  There will be financial penalties for non-performance, as well as the possibility of a corrective plan and constant monitoring to ensure the deliverables are accomplished. Funds will be withheld for unmet deliverables.
