#### 4. Project/Program Description:

Early Childhood Court is a problem-solving court docket that aims to improve outcomes for abused and neglected children under age three. SB 1442 seeks to provide resources to expand upon the existing specialized Early Childhood Court dockets to ensure their adherence to the Safe Babies Court Team approach—an evidence-based approach that includes strong judicial leadership, a multidisciplinary team, monthly court hearings, frequent childparent contact, a continuum of evidence-based services and interventions, and a community coordinator position that works with the local judge to support Early Childhood Court activities. SB 1442 also seeks to assess the potential benefits to Florida's children and families from adopting this approach, and determine whether expansion of the Early Childhood Courts concept in Florida is warranted.

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

To improve outcomes of children under 3 years of age involved in Florida's Early Childhood Courts. The community coordinator positions funded by this legislation are pivotal to the success of the Early Childhood Court approach. The statewide project coordinator position (Senior Court Operations Consultant) is necessary to organize the implementation of the program across all of the participating jurisdictions. The Information Systems Consultant II will track data indicators for the program for all of the participating jurisdictions, which will inform the evaluation component included in this legislation.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Each community coordinator (Drug Court Manager) will work with the judge or magistrate presiding over an Early Childhood Court, support the activities of the court, and facilitate coordination and collaboration among the members of the Early Childhood Court team. The statewide project coordinator position (Senior Court Operations Consultant) will organize the implementation of the program across all of the participating jurisdictions by providing training opportunities (in-person training events and virtual trainings - utilizing state and national experts) and technical assistance activities (conference calls, site visits, and one-on-one coaching). The Information Systems Consultant II will provide the technical support for the case management system that has been built to support the project (The Florida Dependency Court Information System - Early Childhood

Children under the age of three participating in Early Childhood Court. The project is expected to serve 1,000 children and families over the course of the three-year pilot program.

Compared to traditional dependency courts, children in Early Childhood Court are expected to achieve more timely permanency and experience fewer instances of repeat maltreatment. The Florida State University, Florida Institute for Child Welfare will develop research methodologies to evaluate the effectiveness of the program.
