Measurements would be keeping counts for number of bushels/tones, etc of crops successfully harvested and sold and compare those findings with the years where flodding destroyed crops, etc. To protect the public from harm either environmental, criminal, etc by cleaning the drainage facilities, this will reduce potential flooding thus protecting residents and land owners. To measure the benefit would be to monitor drainage during excessive rain events in order to realize flooding potential and mitigate the problems before flooding occurs. A final benefit would be the increase or improvement in economic activity which is directly impacted by the increase in crop production because the flooding issues were resolved. Again, a comparison of production data from the years where flooding destroyed or severly damaged crops
