follow up for a minimum of 6 months to ensure they were hired and/or started a new business. This project will implement employability skills training, small business technical assistance, and links to support (i.e. micro loans, jobs, etc.). Case files will be maintained on each individual that receives case management or is enrolled in a training program. Case managers will contact individuals at least once a month to track progress. Reduce recidivism by providing case management, links to services and training. 80% of individuals with past criminal records will not return to the justice system while enrolled in the program. Reduce substance abuse and divert from criminal/juvenile justice system.
