Funding will be for the replacement of 50-year-old deteriorated concrete stormwater pipes, with ADP polypropylene pipes. This will alleviate unsafe driving conditions on roads that flood extensively with storms, and provide safe passageway for upwards of 35,000 residents.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Regular monitoring of the area by the City.

c. What are the direct services to be provided to citizens by the appropriations project?

This project will provide proper water drainage in an area that floods regularly, and with roadways free of pooling water after rain events, safe driving conditions will be met.

d. Who is the target population served by this project? How many individuals are expected to be served?

35,000 residents and a planned 1000 student school that will also access the roadway.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

A safe roadway, free of flooding, alleviating hazardous road conditions. The City will regularly monitor of area by the city.

A construction bond is required and would be activated if the job is incomplete.
