4. Project/Program Description:

The program will provide a secure, online, tablet-based solution delivering a fully accredited high school education to Florida inmates. The educational program will be fully AdvancED/SACS accredited and include a career-based online high school education component to prepare adult inmates for transition into the workplace. Inmate students enrolled in the program will receive transfer credit for previous high school credits earned and for GED tests that have been successfully completed. The educational program will be open to inmate students considered low education-level (e.g., 5th - 9th Grade) and/or have previously failed the GED.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The specific purpose of the program will be to serve individuals within Florida's adult drop out population that are incarcerated. The intent of the program is to improve their employment and earning prospects upon release; and to reduce their likelihood of returning to prison by providing them an opportunity to obtain high school and career credentials through an accredited online school district.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The activities and services provided will consist of a full services online portal, accessible with a tablet, and offering 92 semester courses (academic and career training), transcript analysis, academic coaches (certified teachers), learning management system, near real-time reporting of student progress, student support services, issuance of high school diplomas, and workforce certificates.

c. What are the direct services to be provided to citizens by the appropriations project?

Direct services provided will consist of online high school instruction, online academic coaching (by certified teachers); transcript analysis for those inmate students that have completed some high school and/or some GED tests; issuance of high school diplomas, and workforce certificates.

d. Who is the target population served by this project? How many individuals are expected to be served?

This project focuses on those low education-level inmates (i.e., 5th - 9th grade level) that lack a high school diploma or an equivalent (e.g., GED). Florida's correctional system has limited capacity for educational services (e.g., of the 99,000 inmates housed by DOC in FY 2015-16, approximately 80% received no educational

programming). An online high school program that leverages tablet-based delivery can provide DOC with the tools necessary to address the unmet educational needs of low education-level inmates (5th to 9th grade level). This project would provide tablet-based educational services to approximately 400 inmates initially; it could potentially expand to approximately 70,000 inmates.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

In addition to the inmates, the Florida taxpayers will benefit. The typical lifetime cost of each high school dropout to taxpayers is approximately \$292,000. Approximately 60% of Florida's prison inmates, and nationally 50% of persons on death row, are high school dropouts. A high school diploma and a career certificate will reduce the probability of going to prison, open opportunities for post-secondary education, and assist them in joining the ranks of taxpaying citizens. Program performance will be reported to the DOC program manager on a monthly basis. This data includes the number of credits earned towards high school graduation by each student; the number of high school diplomas and career certificates awarded to students who complete the program.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Maintain system availability of 95% or greater during a monthly reporting period; 99% or greater each year. Monthly uptime, measured as the total percent of classroom time the system was available to inmate students that month must be 95% or greater. Annual uptime, measured as the total percent of classroom time the system was available to inmate students throughout the reporting year must be 99% or greater. A \$250 credit to the State will be assessed for each occurrence that fails to meet the monthly Acceptable Standard. Any credit assessed will be deducted from a subsequent payment. A \$1,000 credit to the State will be deducted from a subsequent payment. Any credit assessed will be deducted from a subsequent payment.
