Review by Professional Building Contractor and report authored by Director of Operations with latest revision on 1-23-19. Currently unfunded position of Director of Operations. Housing in the means of Safe House, Transitional (Rapid Re-Housing), and Permanent Supportive Housing. Salary for Director of Operations who will oversee the renovation process as well as the agency's day-to-day operations. Housing and wrap-around services to victims of Human Trafficking.

#### c. What are the direct services to be provided to citizens by the appropriations project?

Housing and wrap-around services to victims of Human Trafficking.

Approximately eight youth (up to age of 18), who are victims of human trafficking.
