1. Title of Project: Dolphin Research Center Removal of Organic Material in Dolphin Lagoons

4. Project/Program Description:

In the 1950s the dolphin's lagoons at DRC were deepened by using dynamite. This unique habitat provides an excellent home for the dolphins. As the deepest part of the Gulf of Mexico in our area, marine debris collects in the lagoons. In 1990 DRC received a DEP permit to remove the organic material that had accumulated. Hurricanes Irma and Wilma exacerbated the situation almost doubling the amount of sea grass in the lagoons impeding water flow.

### 11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The depth, water clarity and flow will be restored to the dolphin's lagoons in the Gulf of Mexico. The effects of Hurricane Irma and Wilma will be mitigated.

- b. What are the activities and services that will be provided to meet the intended purpose of these funds?
  - The accumulated organic material that has accumulated in the lagoons due to the winds from the storms will be removed.
- c. What are the direct services to be provided to citizens by the appropriations project?
  - A major component of Marathon's economy is driven by tourism. Dolphin Research Center is the primary destination tourist attraction in our district. Local hotels, restarants and other attraction benefit from increased and positive guest interactions and reviews. DRC employs between 70 and 100 individuals.
- d. Who is the target population served by this project? How many individuals are expected to be served?

  DRC has an average attendance of 70,000. Marathon's population is approximately 10,000.
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Based on a similar project we undertook in the early 1990s we can expect clearer water, better water flow, increased oxygenation of the water. This can be measured using SECHI cards, and the return of native marine species such as lobsters and parrot fish.
