## 4. Project/Program Description:

The City has constructed two wastewater reclamation plants to process irrigation quality reuse as an alternate water supply to replace demands for ground and surface water. This project will re-purpose an existing 8-mile long effluent transfer main to utilize it for reuse transmission and distribution. This project will also extend the reuse line for approximately 1.5 miles to 2 miles to the City's eastern limits to ensure long term sustainability and maximize the environmental benefits of reuse.

   Providing irrigational reuse to customers in and beyond the City of Sunrise corporate limits/region.
- b. What are the activities and services that will be provided to meet the intended purpose of these funds?

  Remove and replace valves, clean and disinfect an 8-mile long 30-inch diameter ductile iron pipeline for irrigational reuse transmission and distribution and extend the line for 1.5 to 2 additional miles.
- what are the direct services to be provided to citizens by the appropriations project?
   Provide irrigational reuse at affordable price and reducing demands on potable and surface waters
- d. Who is the target population served by this project? How many individuals are expected to be served?

  Multiple cities in the region, including Sunrise, Weston, Plantation, Tamarac and Lauderhill both residential and commercial land owners
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project repurposes an existing treated wastewater effluent main that conveys to deep injection wells from the east to the west side of the City. This pipeline, if repurposed and extended, can convey irrigation quality reuse water to build out capacity in the opposite direction, with service to many affordable communities and the older commercial district on the eastern side of the City.

  Reimbursement of funds to the state.
