The project will provide an additional 800-square feet of finished and conditioned space as well as additional site work to support the increase in floor space for the previously funding Town of Wausau Fire Station. The additional floor space will allow for an increase in the number of staff and the ability to store firefighter PPE gear away from the truck bay thus reducing the risk of cancers in firefighters due to toxins attributable to equipment storage in the truck bay.

#### **11.** Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Allow for increased staffing and reduced risk of cancer toxins on firefighter personal protective equipment (PPE)

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Construction of an additional 800 sq-ft of finished and conditioned space and proportional amount of site work.

c. What are the direct services to be provided to citizens by the appropriations project?

Fire rescue and emergency management services will be provided to citizens in Wausau and Washington County. Protection of the firefighters from harmful toxins.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

All citizens in the Town of Wausau and many within Washington County; >800 people.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Benefits include a reduction in the risk of cancer in firefighters due to toxins in their PPE and an increase in the number of staff the station can support over the original design. The number of cancer cases in firefighters can be monitored, toxin testing on the equipment can be performed and the number of operating staff at the station can be measured.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The City will award the contract through a bid process. The bid documents will spell out liquidated damage costs for project overruns. The bid documents will also require the selected contractor to provide performance and payment bonds to the City and a 10% retainer will be withheld until all issues are corrected.
