4. Project/Program Description:

Family caregivers are an invisible workforce often forced into their role without any prior knowledge of how to effectively care for older adults. The Older Adult Caregiver Training (OACT) Program addresses an increasing demand to meet the home health care needs of our growing older adult population by training caregivers on the proper care of older and disabled adults in the home environment and focuses on their mutual health and safety. Community caregivers and those enrolled in Participant Direction Option (PDOs) who self-hire caregivers as direct service workers will benefit from the 7 hours of hands-on classroom and field practicum in-home training provided by an experienced home health industry leader serving South Florida's older, disabled adults, and family caregivers since 1973. United HomeCare is a State of Florida Designated Teaching Agency for Home and Community-Based Care. OACT will also offer in-kind counseling and caregiver support for the caregiver's well-being.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The purpose of the Older Adult Caregiver Training Program (OACT) is to increase the availability and capacity of qualified caregivers dedicated to the care of older and disabled adults in the home setting. The escalating costs of health care and nursing home institutionalization coupled with the rapid growth of the older adult population and a caregiver workforce shortage are factors which are contributing to the dire need for qualified caregivers to provide in-home care preferred by older adults.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Activities include 7 hours of classroom education and field practicum in-home training on core caregiving skills by Registered Nurses (RN) and Home Health Aides. Training is customized to address the care recipient's care plan and ensures the safety, health, and well-being of both the care recipient and caregiver in the home environment. Outreach will be conducted to enroll 400 caregivers in the program. Includes respite services to facilitate the caregiver's participation and in-kind counseling services and caregiver support groups conducted by a Licensed Clinical Social Worker to relieve caregiver stress. Emphasis is on safety and learning how to properly care for an older or disabled adult in the home environment while helping caregivers reduce caregiver burnout. Caregivers will be provided a stipend of \$75 to cover 7 hours of training and transportation costs.

c. What are the direct services to be provided to citizens by the appropriations project?

Caregiving skills will be learned via Field Practicum at-home and Classroom Education for community and family caregivers as well as caregivers of LTC Participant Direction Options. Classroom education consists of 4 hours dedicated to learning skills in CPR, infection control, fall prevention, food preparation safety and feeding, skin care for wound prevention, and techniques for assisting clients with basic and instrumental activities of daily living including personal care, homemaker, emergency protocols, and physical comforts. Field Practicum inhome training of 3 hours will compliment classroom education, and customized to the older adult's care plan. Trainees learn basic home health care procedures; proper use of assistive devices including Hoyer Lift and electric beds; proper and safe transferring; and medication supervision. Trainees will shadow experienced HHAs under the supervision of an RN through observation and training in the home environment.

d. Who is the target population served by this project? How many individuals are expected to be served?

Older and disabled adults and their caregivers living in Broward, Miami, and Monroe counties, including 400 community and family caregivers in need of training on how to care for older and disabled adults in the home or enrolled in Long Term Care Participant Direction Options (PDOs). Eligible trainee participants are caregivers 18+ years of age. Older adults 60+ years and disabled adults 18-59 years will also directly benefit from OACT. Caregivers are either informal (unpaid) or formal (a paid caregiver) providing care in a person's home. Studies show that in 2015, approximately 34.2 million caregivers provided unpaid care to an adult age 50 plus, and the annual economic value of the services provided by unpaid caregivers was \$470 billion [2015 and 2013: Caregiver.org]. Of family caregivers who provide complex chronic care, 46% perform medical and nursing tasks and more than 96% provide help with ADLs or IADLs (basic and instrumental activities of daily living).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Clients and caregivers will benefit from training in core competencies and skill sets for the proper care of older and disabled adults in the home; increased capacity in a vocation where there is HHA workforce shortage with the addition of 400 trained caregivers; and prevent or delay more costly, less preferred, nursing home institutionalization and hospitalizations by keeping care recipients safely at home receiving optimal and improved care from trained and vetted caregivers. Skills will be measured pre- and post-training with an initial skills assessment compared at the end of the program to measure improvement. Data will be collected and assessed using controlled and uncontrolled cohort groups during and post-training to measure hospitalization causes (i.e. falls, number of injuries, etc.), and to measure the value of the program in the prevention of hospitalizations. Care recipients' care plans will be reviewed to ensure that caregivers are trained in the skills they need.
