The computer aided dispatch/automated vehicle location (CAD/AVL) solution will provide real-time vehicle location, schedule adherence information, real-time vehicle health monitoring, automated ADA announcements, and data collection for transit planning and reporting to the national transit database. This project will provide information for routes, system maps, schedules, and real-time arrival times to the public. The project will install a new security surveillance system at facilities and transit centers.

- a. What is the specific purpose or goal that will be achieved by the funds requested?
 - In 2007, HART deployed a CAD/AVL system. Many components of the existing system have reached their end of life. In 2020, the software support expires, exposing critical operations to an increased risk of failure.
- b. What are the activities and services that will be provided to meet the intended purpose of these funds?
 - This project provides real-time vehicle location and schedule adherence information for operators, controllers, and automatic data collection for many on-board events, such as real-time vehicle health monitoring.
- c. What are the direct services to be provided to citizens by the appropriations project?
 - This project will provide user friendly, automated ADA announcements, information for routes, system maps, schedules, and real-time arrival times to customers.
- d. Who is the target population served by this project? How many individuals are expected to be served?
 - The target population would be the residents of Hillsborough County, tourists, and visitors of the Tampa Bay area. Currently, HART serves 52% of 1.41 million residents across the county.
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - To maintain existing reliable service to the public while mitigating the risk of critical system failure. Evaluation of the functional and performance requirements, design review, acceptance testing, and final acceptance will be used to measure the successful implementation of the systems.
