To continue the Fiscal Year 2018-19 Targeted/Specialized Case Management and Wraparound Services to Sex Trafficked Minors throughout the State of Florida. A pilot of this newly introduced element at Redefining Refuge has already had a significant impact on service delivery to our children, resulting in a drastic increase in overall stability and youth engagement in services. This includes a staggering decrease in elopement episodes, the highest number of successful graduates to date and a 500 percent increase in number of youth being served.

Specialized Services for Sex Trafficked Youth will be more readily available and more accessible to Community, Dependant and Delinquent Youth and will remain instrumental in Diversion Services.

Sex Trafficked Youth (ages 11-17), At-Risk Youth, Homeless Youth, Drug Users (under 18), High School Students and Victims of Crime in all 67 Florida counties.

Improve Physical and Mental Health, Improve quality and delivery of education, Reduce Substance Abuse, Diversion from Criminal/Juvenile Justice System, Reduce Recidivism, Enhance Specific Individuals Self Sufficiency. Outcome will be measured in increase and/or decrease in percentage of children.
