Jewish Family & Children's Services (JFCS) Adolescent Diversion and Assistance Program (ADAP) provides prevention and intervention services to adolescents ages 11-17 who are at risk of or have been involved in delinquent behavior, such as domestic violence; shoplifting/stealing; battery/assault; gang activities; bullying; criminal mischief; and substance use. ADAP seeks to prevent the likelihood that participants will become involved with, or have any further involvement in, the juvenile justice system.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

ADAP seeks to prevent the likelihood that the youth will become involved with, or have any further involvement in, the juvenile justice system. This is accomplished through psycho-educational counseling and intensive case management such as: monitoring the youth's community services hours, mandatory court fees, and apology letters; and linking the youth to additional recommended services (i.e. ongoing mental health or psychiatric services).

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

JFCS uses the evidenced-based curriculum, Second Step, for psycho-educational groups and case management. ADAP targets the family system, especially single-parent and multi-sibling households and those facing economic stressors, because family engagement is a protective factor in preventing future delinquent behavior, promoting academic success, and enhancing social relationships. The program monitors the youth's community service hours, mandatory court fees, apology letters and linkages to additional services such as ongoing mental health or psychiatric services. These activities will be provided by funding 2 full time case managers which is the request for this project.

c. What are the direct services to be provided to citizens by the appropriations project?

Upon referral, each youth is assessed in the context of the exhibited delinquent behavior and placed into the most applicable group intervention to address the behavior. Adolescents participate in psycho-educational groups between 5-10 weeks to learn more adaptive behaviors to reduce the potential of entering or re-entering the juvenile justice system. Diversion groups are designed to identify risk factors (substance use, aggression towards others, negative social interactions) and emphasizes learning new skills such as accountability, empathy, communication methods, and conflict resolution. These skills increase appropriate family

communication, academic success, school involvement, and healthy family dynamics. Research indicates that the likelihood of re-offending actually increases as youth are further processed into the juvenile justice system, which supports diverting youth away from the system.

 JFCS Adolescent Diversion and Assistance Program (ADAP) provides prevention and intervention services to adolescents' ages 11-17 who are at risk of or have been involved in delinquent behavior. We expect to serve

The expected outcome is to divert adolescents ages 11-17 from entering or re-entering the criminal justice system. 90% of participants will not engage in criminal behavior within 6 months of program completion.
