1. Title of Project: Liberty County Jail Construction

4. Project/Program Description:

This project, if funded, would result in the acquisition of a location for, and planning, engineering, and construction of a new Liberty County Jail facility. Liberty County is currently in desperate need of a new county jail facility, and is not financially capable of building a new facility without outside funding for this project. The current county jail was originally constructed in the 1940's, with additions in the 1950's and 2006. The currently facility, because of its construction, does not comply with current Florida Model Jail Standards. Additionally, the current facility does not have any mental health holding areas, attorney-client meeting area(s), no contact visitation areas, and has a very inadequate medical area. Also, the current location does not have a secure "sally port" area for the safe loading and unloading of inmates being brought to or removed from the jail. The current location of the jail does not allow for any future expansion of the jail facility.
