a. What is the specific purpose or goal that will be achieved by the funds requested?

Extend senior programming to provide nutrition, socialization, health and wellness, access to healthcare, and prescription pickup.

Transportation services will provide access to a nutritious breakfast and afternoon snack, transportation to and from medical appointments (including dialysis appointments), and prescription drug pickup/delivery.

Afternoon activities to be made available to seniors during extended hours will include individual and group counseling, evidence-based exercise programs, recreational activities, life-learning classes, and socialization.

d. Who is the target population served by this project? How many individuals are expected to be served?

Elderly population, including those with poor mental and/or physical health, economically disadvantaged persons, at-risk youth, and developmentally and/or physically disabled persons. The City of Miramar hopes to be able to expand the current program to serve up to 200 individuals.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increased access to healthy meals where otherwise this population would not have access. Increased activities will improve overall health.
