Due to extensive damage to the two schools from Hurricane Michael, it is not cost effective to repair them to full functionality. It is more fiscally conservative in the long term to build a new PK-8 school centrally located between Grand Ridge and Sneads that will serve both communities. Replacing the two facilities with one consolidated facility will result in a recurring cost savings to the district of \$500,000 per year.
