4. Project/Program Description:

The purpose of the funding request is to eliminate septic tanks, thereby reducing the amount of nitrogen and bacteria entering the groundwater. These reductions will provide for improved water quality resulting in benefits to the environment and citizens. The 2014 Legislature appropriated funds for Midway to conduct a study that would investigate the septic tanks and presumably, support the need for a central sewer system. The study documented problems experienced by homeowners with septic systems and demonstrated how the septic systems are having a negative impact on the environment along with a summary of the surface water samples and soil samples that were taken. In 2016 the Legislature appropriated funds for Midway to hire a consulting engineering firm to survey, design and permit a gravity sewer system to serve 60 homes and 13 vacant lots. The project being requested for funding is the first phase of the overall sewer system.
