- 4. Project/Program Description:

Florida Public Schools Broadcast Video/Digital Media/Film Instructional Grant Program-The project would provide audio-visual technology instructional programs in 30 high and middle schools located in under-served areas of Florida public school districts. Administered by the Panhandle Area Educational Consortium, the grant program will provide funding for advanced digital media production equipment, training and implementation support with the goal of increasing CAPE Industry Certifications and course credits in the Arts, AVV Technology and Communications primary career clusters. When students are awarded CAPE certifications, the local school districts will receive additional funding in the form of CAPE certification incentive funds. Students competing the career cluster will have the option of immediately entering the workforce or may continue to advance in the field through matriculation in technical colleges or state universities.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Increased number of students receiving industry certifications in the audio visual/digital technology field; more trained workers to meet future job demands.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Thirty middle and/or high schools will receive funding for an audio/visual technology program that will lead to CAPE industry certifications. The program will fund AV/technology equipment, server storage capacity and technical support for 24 months, teacher professional development, and will provide students with opportunities to earn course credits that are CAPE industry certified.

c. What are the direct services to be provided to citizens by the appropriations project?

Students and school districts will be the initial recipients, followed by Florida businesses who employ persons with digital media skills and industry certifications. The Department of Economic Opportunity projects 214,000 new jobs in related fields over the next 7 years.

d. Who is the target population served by this project? How many individuals are expected to be served?

Students in 30 middle/high schools. Depending on size of school, between 10,000 and 20,000 students served each year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Increased number of students receiving industry certifications in the audio visual/digital media field; more trained workers to meet future job demands. The Department of Education collects data specific to Industry Certifications as well as annual enrollments in relevant courses. This data will be used to create a baseline to determine project results.

Withhold a portion of grant funds until deliverables are met.
