- 1. Title of Project: Heart Screening for Low Income FL Student Athletes

- 4. Project/Program Description:

Too many times the headlines read "School takes action following student's death". We ask: "Why not take action to help prevent the death?" Sudden Cardiac Arrest (SCA) kills more student athletes than any other cause (Meyer et al., 2012). It is also the number one cause of all student deaths on school property in the country. Student athletes are at an even higher risk of dying than the general population, despite the fact that they receive annual physical examinations as part of their athletic participation. Recent studies have shown the physical to be woefully inadequate in recognizing cardiac problems that cause SCA (Zeltser et al., 2012). An electrocardiogram (ECG) - which is currently advised for all athletes by the Florida High School Athletic Association - is an effective and affordable tool to accurately detect children at risk of SCA, and is proven to save lives in the short and long term. The purpose of this funding is to significantly reduce the incidence of SCA.

#### **11.** Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

Funding will provide more than 50,300 ECG heart screenings for low income, at-risk student athletes in 10 Florida counties. Matching funds will come from charitable fees collected from approximately 33,000 additional student athletes.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Electrocardiogram (ECG) heart screenings performed by WWPF using portable equipment, trained staff, and the top pediatric cardiologist in the state and country. We reach out to Florida school districts that are willing to require ECG screening for athletic participation and subsequently contract with us to incorporate the program in their middle schools and high schools. We coordinate with the school's Athletic Trainers and Nurses to publicize and distribute promotional materials and host the events. All students and staff are welcome to participate, but athletes are the primary focus due to their higher risk of SCA. After the screening, the



interpreted ECGs are returned within 3-7 business days along with potential diagnoses for abnormal ECGs, suggested follow-up testing, and information about potential diagnoses as it pertains. Interpreted ECGs are divided into 3 categories depending on the level of risk for SCA: low risk, follow-up and high risk.

## c. What are the direct services to be provided to citizens by the appropriations project?

Potentially life-saving electrocardiogram (ECG) heart screenings to student athletes and interested students. This service will save lives and significantly reduce the state of Florida's liability to the leading cause of death on school campuses and in sports: sudden cardiac arrest.

d. Who is the target population served by this project? How many individuals are expected to be served?

50,300 low income student athletes. An additional 33,000 will also be served for a total of 88,300.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Generally, 1 in 300 students is detected with an abnormal heart condition through ECG screening, in many cases these conditions are life threatening. At this rate, as many as 168 student athletes and their families could be impacted. Of the 88,300 students screened, an estimated 293 students could be impacted. The ultimate measure is the number of lives saved from sudden cardiac death.
