FICS works at the neighborhood level to strategically plan and fill critical needs. The Town n Country area (33614, 33615, 33634, 33635, parts of 33624, and 33625) is the most densely populated area in our county (unincorporated) with high numbers of children and an increasingly high number of refugees and asylees from Venezuela who are facing mental and physical health disparities. FICS reopened and has been re-purposing a closed county park, Morgan Woods Recreational Center, into a community wellness center with staffing, literacy programming, intergenerational arts, sports/playground, and mental and physical health programming - including zumba and mindfulness, social support, and healthy lifestyles. The Park is located in zip code 33634 and serves a community of Title 1 schools and a low-to-moderate income community that is highly Latino/Hispanic suffering from high rates of diabetes, heart disease, and obesity. We have secured \$96,700.

#### 11. Program Performance:

#### a. What is the specific purpose or goal that will be achieved by the funds requested?

FICS works at the neighborhood level to strategically plan and fill critical needs to improve their quality of life and well-being. We meet our mission of partnering with communities to help them achieve their goals through research, education, training, services, and the arts. This LBR is critical to Town n Country's vulnerable populations. Partners in Well-Being is a research-based program with seven different services designed to meet the needs for health and mental health of the multicultural and low-income populations in our zip codes. We aim to improve mental and physical health, reduce substance abuse, improve literacy, reduce delinquency, and enhance individuals' financial self-sufficiency.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The Town n Country area (33614, 33615, 33634, 33635, parts of 33624, and 33625) is the most densely populated area in our county (unincorporated) with high numbers of children and an increasingly high number of refugees and asylees from Venezuela who are facing mental and physical health disparities. #### c. What are the direct services to be provided to citizens by the appropriations project?

1) Literacy and Health Literacy, 2) Health education; 3) Fitness classes; 4) Diet and nutrition; 5) Case Management (financial, Bio-Psycho-Social) and referrals; 6) Enhanced exercise for youth and adults/Lifestyle Changes; 7) School Readiness/VPK/Afterschool; and 8) Transportation. This LBR will provide literacy (ESL, health literacy to English speakers and non-English speakers), afterschool/summer/OST, VPK, financial education, mental and physical health coaching, support, referrals, health education, access to affordable wellness classes such as zumba and yoga/mindfulness, healthy lifestyle coaching, evidence based programming for diabetes prevention, and management across the lifespan to at least 500 families per year.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

We aim to reach entire families which correspond to the following numbers based on our many years of research. The average family we serve in Town n Country has 3.5 children. Therefore, we aim to reach 300 multicultural families across color and language who are between 100% and 350% of the poverty line with a total reach of 1,050 and a total of 500 participating each year.



e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

FICS will measure outcomes pre/post testing, signings, and referral tracking for each outcome listed. Outcome I - Improved physical health: 1. Improved access to health screening and services for high-risk adults and youth; 2. 80% of clients will have increased their physical activity by at least 50% in post-tests vs. pre-tests; 3) 80% of clients will attend at least two classes of zumba, mindfulness, or health education. Outcome 2 - Improved mental health: 1. Provide holistic wellness education to at least 100 adults and 100 youth; 2. Provide mindfulness, zumba, and walking clubs for at least 200 adults who otherwise would not have access; 3. Retain at least 80% of youth and adults over 1 month; 4. At least 80% will report improved mental health. Outcome 3 - Reduce Substance Abuse: 1. 100% of clients will be assessed for substance abuse and if they are having a problem they will be referred; 2. 80% of clients will attend health education classes in which SA is discussed.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Failure to meet deliverables: 1) less than 70% of deliverables; 2) between 75-85%; and 3) over 85% of deliverables, 10% funding cut in next year.

The Hillsborough County Department of Parks and Recreation is the owner. FICS is a leaseholder with a 3-year renewable contract for space usage.
