1. Title of Project: 44th Avenue East Extension

4. Project/Program Description:

Manatee County intends to provide an east/west thoroughfare to support an anticipated increase in capacity and help maintain the county's adopted levels of service for surrounding roadways including SR 70 and SR 64. This thoroughfare should help alleviate demand at the I-75/SR 64 and I-75/SR 70 interchanges. This project is part of the county's comprehensive plan and includes construction of approximately 5 miles of roadway improvements from 45th Street East to Lakewood Ranch Boulevard. The proposed roadway will include a four-lane divided roadway with sidewalks, bike lanes/multi-use path, street lighting, a bridge over the Braden River, an overpass over I-75, and a crossing over a reclaimed water storage lake. This section will include four, 12-foot lanes, a 22-foot median, curb and gutter, four-foot bike lanes, and five-foot sidewalks in each direction. The total cost for this section of road is \$125 million. Manatee County plans to borrow \$88 million in 2019 to complete the road.

The specific purpose of this project is to provide an additional east/west thoroughfare that will increase traffic capacity to meet current and anticipated growth in Manatee County. State funding will offset the county's total costs for construction of \$125 million.

 Construction of approximately 4.3 miles of roadway improvements on 44th Avenue East, from 45th Street East to Lakewood Ranch Boulevard.

 Additional east-west roadway capacity in south Manatee County, which will reduce congestion on parallel sections of SR 64 and SR 70 and at their interchanges with Interstate 75.

Creates additional capacity for about 36,000 vehicles per day on a 4.3 mile corridor and reduces demand on the combination of parallel SR 64 and SR 70 by 15,000 to 21,000 vehicles per day, thereby reducing congestion and eliminating a theoretical demand for a total two additional lanes on these "built-out" state facilities. Benefit estimated by comparing travel demand model output for build and no-build scenarios. (Travel Demand Model was CUBE-based FSUTMS applied to MPO's 2035 LRTP datasets.)

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Performance bond, 10 percent contract retainage, and liquidated damages.
