#### 4. Project/Program Description:

America's Second Harvest of the Big Bend (SHBB) services multiple counties in the panhandle, including those in the most rural areas of the state and those that were severely impacted by Hurricane Michael. SHBB will be using the funds to initiate an aggressive mobile pantry program to get a variety of food products to the food insecure population in this region of the state. This program will be rolled out in conjunction with Feeding the Gulf Coast, a sister member of the Feeding Florida network, in order to ensure comprehensive coverage of all counties. Mobile pantries are most effective in low population density zones where clients have limited transportation options. Evaluations will be conducted using a variety of analysis tools to determine the most efficient way to reach this segment of the population.

c. What are the direct services to be provided to citizens by the appropriations project?

Funding will be utilized to provide food and nutrition education to food insecure Floridians in this region. It will also be used to enhance the food distribution infrastructure to ensure that current and projected needs can be accommodated.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population are those individuals and families that are food insecure as defined by multiple state and national assessments. This includes, but is not limited to, Feeding America, the United Way Alice Report and independent food bank analyses. It is estimated that this is over 400,000 people in this area of the state.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Reduction in food insecurity levels in all impacted counties. Measured by the number of mobile pantries we can get out to these remote and damaged areas of the region.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Second Harvest of the Big Bend must submit evidence of performance prior to drawing down the funds. Proposed reimbursement is based on the projected average cost of \$3,695 for every mobile delivery and is paid after the distribution is made. The agency has the authority to withhold payment for failure to perform.
