- 1. Title of Project: Hurricane Michael Altha Disaster Recovery Request

- 4. Project/Program Description:

As a result of damages from Hurricane Michael, the Town of Altha experienced significant damages. Although the town has very limited staff, the available workforce worked around the clock to restore operations to an acceptable standard in days following the storm. Since that time the majority of the operations have been stabilized, but much more still needs to be completed. A primary factor in the delay of the recovery has been the lack of available funding. As a rural, fiscally constrained community, the Town of Altha has extremely limited resources to meet the overwhelming needs that have been identified. This request, if funded, would allow the town to move forward with important projects that will ensure the safety and well being of the citizens of the Town of Altha.

a. What is the specific purpose or goal that will be achieved by the funds requested?

The purpose of the funding is to assist in the recovery efforts from Hurricane Michael damages. The intent is to not only restore the town to pre-storm conditions, but to also improve disaster resiliency to reduce the impact of future disasters. The town suffered tremendous damage from Hurricane Michael and does not have the funds to make these disaster recovery efforts on its own.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Restoration of damaged facilities and upgrades to facilities to promote resiliency.

c. What are the direct services to be provided to citizens by the appropriations project?

The citizens of Altha will benefit from the reconstruction of the town's park, community center, library, Town Hall, and many other town properties and water system repairs which will provide more reliable services for all.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population of this project are the citizens of Altha. It will serve approximately 600 people that are currently living within the town limits.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The project will enhance the town and uplift the citizens of Altha after it was devastated by Hurricane Michael. Each component of the proposed improvements will be measured on an individual basis. The proposed funding for each category will be tracked and results documented for those efforts. The town will never have the funds to restore itself to pre-hurricane conditions without the financial help of the state.
