- 4. Project/Program Description:

Funding would cover the non-reimbursed costs of debris removal as a result of Hurricane Michael. The storm left tons of debris in and along the sides of many miles of local streets and private roads within the City of Quincy. In many cases, sewer lines are located in close proximity to these roads and resulting debris piles. The sewer lines are located less than 12 inches from the surface in many places. The weight of the debris is sure to damage and crush the lines over time and must be removed. In addition, the storm left tons of debris in neighborhoods and public and private roads that is still being recovered. This project will fund the removal of this debris which is not covered by the state and national emergency disaster funding.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Reimbursement of funds that the City of Quincy expends for debris removal that are not covered by federal or state sources.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The activities include contracting with a debris removal company with equipment necessary to remove the debris from the sewer and rights of way; and payment of overtime for city public works employees to remove debris from local streets and private roads.

c. What are the direct services to be provided to citizens by the appropriations project?

The removal of debris from the sewer lines will ensure uninterrupted sewer services to 95 percent of the residents served by the utility and protect the tributaries and waterways of the Little River and other minor water bodies from environmental damages caused by sewage spillage. Further, debris removal on local streets and private roads will eliminate an immediate threat to lives, public health and safety, eliminate immediate threats of significant damage to improved public or private property, and ensure the economic recovery of citizens, businesses, and the community at large.

d. Who is the target population served by this project? How many individuals are expected to be served?

Commercial and residential residents receiving municipal services (approximately 11,280).

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit is the provision of reliable sewer services to citizens and businesses. The methodology is to maintain a record of the number of sewer-related work orders that adversely affect services to the customer pre- and post-Hurricane Michael and the tracking of DEP citations and penalties related to sewage spillages. local streets and private roads, the time lapse between the storm event and return to normalcy in civic and business life.

Withhold partial funding until proof of debris removal is provided.
