11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The funds will provide a model program requiring middle school students in grade 8 to take a minimum of one semester of health.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Comprehensive Health Education curriculum will address the physical, mental, emotional and social dimensions of health. It is designed to motivate and assist students to develop lifelong healthy habits, addressing topics like: personal, family, community and environmental health; nutrition; injury prevention and safety; sexuality education; mental and emotional health; prevention and control of disease; and substance use and abuse.

c. What direct services will be provided to citizens by the appropriation project?

The curriculum will be delivered in a one semester, mandated class at the 8th grade level.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is 8th graders in the School District of Lee County. The number of children expected to be served is approximately 6,500.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Research indicates that school health education programs can reduce health risk behaviors such as tobacco use, poor nutrition, lack of physical activity, drug and alcohol use, as well as actions that increase stress, and risk of injury, and violence. This ensures reinforcement of health messages that are relevant for students, helps to increase academic achievement by removing barriers to learning and ultimately meets community needs by providing healthy, well prepared members to the workforce. The methodology by which the outcome will be measured includes pre and post assessments, analysis of SESIR data, analysis of mental health assessment team data and that of our community partners.
