11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The Regional Entrepreneurship Centers and Statewide Small Business Loan Fund provide business management training, lending solutions, and other services to minority-owned small businesses. This program also provides technical assistance and access to capital via a revolving loan fund for startup and expanding businesses, particularly minority-owned and women-owned throughout Florida. The goal of the Small Business Loan Fund is to create additional capital and sustain existing viable minority owned small businesses that create jobs for community residents and build community wealth.

b. What activities and services will be provided to meet the intended purpose of these funds?

This request supports programming in the counties and surrounding communities: Broward, Palm Beach, Orange, Pinellas, and Duval counties. The three components of this request are: 1) Regional Entrepreneurship Centers (ECs) provide opportunities for small business owners and entrepreneurs to gain access to market prospects, technical support, and capital to improve and grow their businesses. 2) Statewide Small Business Loan Fund: Broward County administers the Small Business Loan Fund for lending throughout the state to small businesses, in particular minority-owned small businesses, who have difficulty accessing funding from mainstream markets. 3) Community Engagement: Participation in activities to strengthen partnerships including working with local anchor institutions to discuss the challenges and opportunities for minority owned small businesses doing business in under-served communities through open forums, community meetings, and ecosystem development.

c. What direct services will be provided to citizens by the appropriation project?

This project includes three components: 1) Entrepreneurship Centers (ECs): provide marketing, orientations, business assessment, group trainings and workshops, individual coaching, business case management, business site visits, lab hours (open time for business owners for learning), outreach events, and partnership building with local and regional resources to enhance services in the small business ecosystem. 2) Statewide Small Business Loan Fund: conducts outreach, marketing, responding to loan inquiries, process loan application, origination, underwriting, and managing loan advisory board meetings. 3) Community Engagement: activities to strengthen partnerships and discuss the challenges to minority owned small businesses doing business in underserved communities through open forums and community discussions.

d. Who is the target population served by this project? How many individuals are expected to be served?

The funds will serve minority-owned and women-owned small businesses to provide capital and deliver technical assistance and education to qualifying small businesses. If fully funded, this program expects to serve over 3,000 residents across the state, including the following counties: Broward, Palm Beach, Orange, Pinellas, and Duval Counties and their surrounding areas.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

1. Increase in number of new and/or expanded businesses; increase in revenues of existing businesses - incorporation documents; documented revenue/financial statements

2. New jobs created and/or sustained through start-up or expanded businesses - number of new jobs and wage level - as reported by business owners

3. Strengthen current partnerships and build new relationship with other local or regional anchor institutions to connect small businesses to untapped resources
