1. **Project Title** FIE: Florida Rural Early Learning Exchange Network2. **Senate Sponsor** Bill Montford3. **Date of Request** 11/12/20194. **Project/Program Description**

The FIE: Florida Rural Early Learning Exchange Network is designed to increase access to and use of community resources to improve outcomes for children birth to age five in other rural counties (e.g., Liberty, Madison, Wakulla, Taylor, and Gadsden) by:

- Creating a community-researcher partnership designed to strengthen and leverage access to existing resources and identify needed programs and services that address the limited support available to rural counties;
- Collaborating with rural partners to identify community desired outcomes and set a shared agenda to achieve those outcomes, and;
- Working with public libraries, schools, child care centers, other community agencies, and families to increase children's literacy readiness and use executive functioning that help children acquire the knowledge and skills to be successful in school and life.

11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Improve school readiness outcomes for children living in rural communities by partnering with public libraries, schools, child care centers, businesses, government agencies, other community agencies, and families to provide programs and services designed to help children enter kindergarten ready to read, ready to learn, and ready to succeed.

b. What activities and services will be provided to meet the intended purpose of these funds?

- Expand the successful, existing, literacy-focused partnership model in Jefferson County to other rural counties (e.g., Liberty, Madison, Wakulla, and Gadsden).
- Establish a community-researcher partnership (e.g., set a shared agenda, identify common measures of student progress, collect benchmark data, identify existing and new resources to support shared initiatives).
- Increase community awareness (e.g., kickoff rally, community dialogue) of the importance of helping children acquire knowledge and skills they need to be successful learners.
- Initiate a family- and child-focused program that help families become involved in their children's literacy growth at home and in the community.
- Implement a volunteer reading program for preschool, kindergarten and first-grade partner classrooms.

c. What direct services will be provided to citizens by the appropriation project?

Types of services to be provided will be jointly decided by anchor rural partners based on identification of a shared agenda and problem/issues identified as "best" starting point for the FIE: Florida Rural Early Learning Exchange Network.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population includes rural economically disadvantaged birth to five-year-old children and their families, library staff, teachers, and community organizations serving children birth to five (e.g., Head Start, Early Head Start, and child care centers). Year 1 start up will serve approximately 400-800 children and adults.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

1. Improve Quality of Education: In Year 1, the measures will be: (a) establishment of Florida Rural Early Learning Exchange Network; (b) setting a common agenda with agreed upon measures; (c) gathering baseline VPK assessment results; and (d) developing and implementing at least one Rural Network practice-focused mini-project that addresses an agreed upon problem/issue. 2. Improve Economic Activity: The Network will help children acquire and use the knowledge, skills, and dispositions needed to be successful readers. Evidence continues to mount that high-quality, intensive early childhood interventions - particularly for children from low-income families - have lasting positive impacts and are much more cost effective than later remediation efforts. The economic return for high-quality interventions is higher than any other youth-centered remediation intervention. High-quality early childhood programs can yield a \$4 -\$9 dollar return per \$1 invested.
