### 4. **Project/Program Description**

This proposal would support the launch of a pilot project to demonstrate the power of long-term, professional mentoring for students facing the greatest obstacles (those experiencing intergenerational poverty, at-risk of abuse/neglect and/or who are homeless) at low-performing schools. Called the Friends of the Children (FOTC) School Success pilot, the project focuses enrollment of 29 kindergarteners at school(s) in Hillsborough County, and will measure impact of the program for a total of 53 Hillsborough County students over 3-years in the following areas: school attendance, school discipline, acquisition of social/emotional skills, positive parental engagement, and - for older youth - progress in school achievement/course progression.

#### 11. Program Performance

#### a. What specific purpose or goal will be achieved by the funds requested?

The goal of this 3-year pilot project is to focus on the most vulnerable children and demonstrate improved school attendance, reduced school discipline, and improved parental engagement, all of which are foundational to the advancement of learning gains for students experiencing multiple, compounded barriers to school success (including intergenerational poverty, foster care, homelessness, parental incarceration, and parental substance use/mental health disorders).

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Enroll 29 children at the end of their kindergarten year into the Friends – Tampa Bay program; Salaried, full-time, professional mentors ("Friends") will provide individualized support to each child for 3-4 hours/week, 2 hours/week in the classroom; From kindergarten through high school graduation, Friends will build skills and advocate for children and parents to maximize school success. Friends will partner with schools, non-profits to support child and family progress toward outcomes.

#### c. What direct services will be provided to citizens by the appropriation project?

Friends will spend 4-6 hours per week with each child to improve the child's: 1) development of social-emotional skills; 2) avoidance of school absences, suspensions, and school expulsion and progress on school achievement goals; 3) engagement in healthy nutritional practices and physical activities; and 4) development of positive peer and adult relationships. Friends also support caregiver skill-building, building of social capital, and engagement in the child's education.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

29 of the most at risk elementary school aged youth and their caregivers (29 or more) will be newly enrolled in the program. The project will measure outcomes for a total of 53 Hillsborough School District students, who are elementary to middle school aged. All of the students students will have experienced multiple, compounded barriers to school success (including intergenerational poverty, foster care, homelessness, parental incarceration, and parental substance use/mental health disorders).

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The ultimate goal is that every student enrolled will graduate from high school, avoid the juvenile justice system, and avoid parenting as teens. During the project period, we expect to see improved attendance, reduced school discipline, development of social/emotional skills and (for older youth), positive course progression in school. These outcomes will be measured using school report card data, school records, and Friends outcome recording in an Efforts to Outcomes (program performance management) data base.

### f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Failure to meet deliverables may result in the witholding of funds, disallowance of costs, and/or suspension or termination of the appropriated fund award.
