11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Reduce the incidence of violence through health and wellness services to trauma-impacted youth; (2) lower rates of aggression and violent behavior by helping youth develop emotional self-awareness and control, positive social skills, problem-solving, and conflict resolution; (3) provide mentoring and intensive wraparound services that address environmental factors, family, and daily living; and (4) implement a community-based platform to improve positive youth and family outcomes while preventing violence, delinquency, victimization, and revictimization by improving the response to children's exposure to violence and enhancing public safety in targeted communities and schools.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Service Delivery – Implementation Plan has five components: Youth Focused Services, Youth Group Meetings, One-on-Ones, Family/Caregiver Intervention, and SEEDS Success Team (SST). The components of the plan include mentoring, academic assistance, life skills training, strategies for learning to live violence-free, family engagement, education enhancement, and prevention/intervention services focused on social emotional learning.

c. What direct services will be provided to citizens by the appropriation project?

Cognitive guidance sessions including goals and informational content. The program will use Cognitive Based Interventions for Trauma in Schools (CBITS), Trauma Focused-Cognitive Behavioral Therapy (TF-CBT) and Promoting Alternative Thinking Strategies (Paths) to build life skills, such as communication, initiating and maintaining relationships, and promoting positive youth development, such as handling anger and managing stress.

d. Who is the target population served by this project? How many individuals are expected to be served?

Liberty and West Park are predominately African American neighorborhoods plagued by gross inequality and the persistence of public health issues that increases obstacles to educational advancement, social mobilty, and access to social and human services. The prevalence of gun violence is an epidemic, placing youth at high risk for the development of mental health difficulties which make them more likely to experience acute environmental stressors such as post-traumatic stress disorder, substance abuse victimization, and exposure to high levels of community violence.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The projected outcomes are: structured process for youth and parents/caregivers to learn about trauma, while developing strategies to reduce related stress, control emotions, and modulated action associated with challenges occurring during various life experiences.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?
